Whereas, the Tahsildar Yavatmal and the sub divisional officer Yavatmal have proposed to make available the alternate forest land admeasuring 1.20 hectar aar for the construction of 600 m long and 10 m wide minor bridge between K.M. 1/200 to 1/800 on Wadgaon Jamb Nakapardi Road, MDR 92, along with the approach road on the forest land vide Rev. Case no. 03/ LND-18/2023-24 Mouja Murzadi, Tq. & Distt. Yavatmal.

And whereas, the Sub-Divisional Officer, Yavatmal has submitted the proposal to this office after fulfillment of the errors. After perusal of the said case, it reveals that, the Deputy Forest Conservator, Yavatmal Forest Department has submitted the demand for land in prescribed statement A, B, C, D.

In the matter, when the Talathi, Murzadi has done the spot inspection of the said land, it was found that, the land bearing Gat no. 143, Area 2.06 hectar is suitable for the alternate forestation and there is no encroachment of anybody (private person). The report has been submitted that, there is no impediment for making the aforesaid land available after fulfillment of all the government rules and getting all the government permissions.

In the matter, the Deputy Superintendent of Land Records, Yavatmal has submitted the measurement map (C copy) of the said land.

In the matter Assistant Director, Town Planning, Yavatmal has submitted the report that, the ownership and the location of the said land could not be ascertained as the 7/12 extract and the map of the said land are not received, yet the said use of relevant land is permissible as per the provisions of Consolidated Development Control & Incentives Regulations, for the Sanctioned Regional Plan applicable to Yavatmal.

In the matter Chief Executive Officer Zilha Parishad, Yavatmal submitted the recommendation certificate that, there is no objection for the aforesaid work as per the no objection certificate given vide resolution passed on 29/04/2023 in the Gram Panchayat monthly meeting no. 5/1.

It is seen that, the approval has been received for the improvement of the Wadgaon Jamb Nakapardi Road, MDR-92 km 0/150 to 6/700 per the Public Works Department Government Resolution no.-PLN-2018/CR-(2669)/ni-3, Dt. 15/11/2018.

Hence, the Sab- Divisional Officer, Yavatmal and the Tahsildar, Yavatmal have submitted the proposal for sanction of the said land. Accordingly, considering all the aspects, as per the Rule 6(3)(b) of the Mharashtra Land Revenue (Disposal of Government Lands) Rules, 1971 and in accordance with the Public Works Department Government Resolution no.-PLN-2018/CR-(2669)/ni-3, Dt. 15/11/2018, and on the administrative sanction for the improvement of the Wadgaon Jamb Nakapardi Road, MDR-92 km 0/150 to 6/700, the order is hereby passed for the sanction of the land bearing Gat No. 143, admeasuring 1.20 HR (E Class) in the south-east side out of the 2.06 HR area, as the alternate non-forest area in exchange for the forest area being affected by the consruction of the 600 m

long and 10 m wide minor bridge between K.M. 1/200 to 1/800 on Wadgaon Jamb Nakapardi Road, MDR 92, along with the approach road.

Terms and Conditions

1. The applicant shall hold the said land as Occupant Class-2 land. Therefore, the said land or any part of the land shall not be transferred/mortgaged/BOT by any means without the prior sanction.
2. If, any dispute is created in the future in respect of the said land, then it has to be given back to the government.
3. The Rules relating to the construction applicable to the local Authority, shall be followed.
4. The concerned department shall follow the Urban Development Rules, while carrying out the construction and shall also follow the rules applicable for the A, B, C class Nagar Parishad.
5. If the said land is not required for the concerned department then, the said land has to be given back to the government.
6. No partition off the said land shall be allowed.
7. No impediment should be allowed to be created for the moral rights and the easements of the adjoining plot holders of the said land.

10. After taking the possession of the land, it shall be the responsibility of the concerned department to protect and look after the said land.
11. The land shall be used for the purpose for which the said land has been granted
12. The Sub-divisional Officer, Yavatmal may impose the terms and conditions which shall be found necessary on his level.

13. After considering the above terms and conditions, as well as considering the Maharashtra Land Revenue Code and the Maharashtra Land Revenue Rules 197, thereunder, a self attested Indemnity Bond on rupees 100 stamp paper shall be taken from the grantee, having included therein the other/above terms and conditions and acceptance thereof.
14. The Government shall have the rights to the minerals/minor minerals in the said land.
15. The care shall be taken so that, the service and easements of the adjoining people shall not be affected due to the development of the said land.
16. The Rules the Directions coming from the Government from time to time, shall be followed.
17. As per the directions given in the Revenue and Forest Department, Government Resolution Date Sankirn-05/2006/pr.kr.43/j-1, Dt. 31st October 2006, the Execution of the Document of Agreement at the time of giving the said land on lease/on occupancy or on renewal of the lease, should be made as per the Bombay Stamp Act 1958 and only there after the possession shall be given of the said land. Also the procedure shall be followed as per the directions given in the said Government Resolution.
18. The use of the said land shall be done for the purpose for which the said land has been granted. Other use shall not be permissible.
19. After taking the possession of the said land, the name of the grantee shall be recorded in the record of rights.
20. It shall be binding to follow the above terms and conditions.

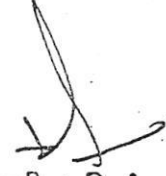
