Subject: Diversion of 4.8639 ha of forest land in favour of M/s Bloot Fozal Hydro Pvt. Ltd. for the construction of Bloot Fozal SHEP (5.0 MW) within the Jurisdiction of Kullu Forest Division, District Kullu, HP. (Proposal No.FP/HP/HYD/ 38741/2019).

2. The point-wise reply to the EDS is given as under:-

1.	As per the DSS analysis, Area evaluated for the proposed forest land is approx. 2.85 (ha.) however proposed diversion area is 4.864 (ha.). State Govt shall revise the KML and mark all the components in polygon shape and in distinct colours. Area of each components should be similar to the area mentioned as S.No-4, part-I.	The revised KML file having total area of all components are 4.8639 ha. has been uploaded at Sr. No.4 of Part-I.
2.	Total 06 Dumping sites has been proposed in the forestland, DS-03/04/0506 is exactly situated centrally between the Khad/Nullah/mountains and DS 1 to 2 situated at the bank of the Nullah, from where stream following through, therefore State Govt. may explore to shift the dumping sites to Non-forest land, if possible. Otherwise change the location of dumping sites. Since all of these Dumping site will not only hindered the flow of the Khad but also cause landslide and destruction to the nearby landscape.	The U/A has intimated that dumping sites were marked inadvertently over the stream. As per actual layout plan, all the dumping sites are above the stream/ nullah and revised kml file has been uploaded in Part-I. Further, non-forest land is not available in the vicinity of the project for which non-availability certificate has already been submitted. Therefore, dumping sites have been proposed over forest land which cannot be avoided.
3.	State Govt. shall provide the details of trees/saplings in the proposed dumping sites each, duly authenticated by DFO concerned. Also, submit an undertaking that no tree shall be felled in the proposed Dumping sites.	The needful has been done. Revised enumeration list of trees with Khasra Number details has been uploaded against additional information of Part-II and undertaking that no tree shall be felled in the proposed Dumping sites has been uploaded in additional

4.	In the S.No-4, part-I (Component Wise Break Up), the components for "WORKING area and Footpath" of total area 0.2905 ha & 0.0166 ha respectively has been proposed. State Govt shall clarify the rationale of this components with valid justification and relevant documents, if any, duly authenticated by DFO concerned.	U/A has intimated that component "Working Area" will be used temporarily during construction work of the project and will be surrendered back to the Forest Department after construction. Further, component "Footpath" has been proposed as an access between the components of the project and undertaking from UA to surrender the temporary Forest Land to Forest Department after construction work is completed has been uploaded in additional information of Part- I at Sr. No. 43
5.	State Govt shall submit the details (calculation sheet) of transmission line above ground/below ground (length and width, No of poles/area of each/ROW/ Minimum clearance between conductor Trees), duly authenticated by DFO concerned. Also, mark the same in the KML and add the same in legends.	The detail of transmission line has been uploaded at Sr. No.32 & 36 against additional information of Part-I and accordingly same has also been marked on the revised KML file uploaded in Part-I.
6.	Since the proposal involves private land (0.0628 ha), however no documents regarding the consent of the private landowners by the way of sale/gift Deed/ NoC or any other form is required to be submitted/uploaded before Stage-I.	The process of acquiring non-forest/private land is in progress and is on the verge of completion. The detail of same will be submitted before Stage-II approval to MoEF & CC, GoI and an undertaking in this regard has been uploaded at Sr. No.40 in additional of Part-I.
7.	State Govt shall provide the fresh NOC from IPH/HPPWD/HPTCL/HPSEBL/Fishery department with the actual name of the UA.	NOC from IPH/HPPWD /HPPTCL/HPSEBL/Fisheries have been applied for and will be submitted before Stage-I approval and an undertaking in this regard has been uploaded at Sr. No.40 against additional information of Part-I.
8.	In this proposal TEC has been accorded to M/S Bloot Fozal Hydro Private Ltd., & Apply Valley Resorts (P) Ltd." However supplementary IA is signed between the "M/S Baloot Fozal Hydro Pvt Ltd. "and MoU is signed/accorded between M/S Apple Valley Developers. State Govt shall provide the detailed justification with documentary evidence separately for each, if any duly authenticated by DFO concerned.	The copy of TEC issued in favour of Bloot Fozal Hydro Private Limited has been uploaded at Sr. No.39 in additional information of Part-I.

9.	Letter of consent is accorded to M/s Apple Valley Developers and that is for 2.00 Mw, however proposal is submitted by UA "M/S Bloot Fozal Hydro Private Ltd." and for capacity of 5 Mw. State Govt shall provide the revised/fresh Letter of consent with the name of the UA applying for the proposal.	Letter of consent is accorded to M/s Apple Valley Developers but the Implementation Agreement (IA) has been carried out in favour of M/s Bloot Fozal Hydro Power Pvt. Ltd. and same has been uploaded at Sr. No.39 in additional information of Part-I.
10.	State Govt. may provide the detailed power evacuation layout plan till the power station and same shall be marked on the KML, duly authenticated by DFO concerned.	In this regard DFO Kullu submitted that as per HPPTCL letter uploaded at Sr. No.32 against additional information of Part-I, the Power evacuation of Bloot Fozal SHEP will be done through LILO from Kathi SHEP Power House. Further, layout plan of T/line duly approved by concerned DFO has been uploaded at Sr. No.36 against additional information of Part-I.
11.	Component of Ropeway has been marked in the KML which is connect from one side to road to power house and one side is for dumping site-03, and working area. State Govt shall clarify the necessity of the proposed components.	In this regard, U/A has intimated that component of Ropeway connecting from road to power house will be used temporarily for carrying the raw material during the construction of project and after construction the area of the same will be surrendered back to the Forest Department.
12.	Bridge components has been marked in the KML, however no exiting road for the approach to this project is visible-marked. State Govt shall mark the existing road from which the approach to project will be used.	A road from Kukari to Kathi has been proposed by HPPWD and detail of the same has been uploaded at Sr. No.37 against additional information of Part-I. The proposed bridge will connect to this road and will be used as an access to the project.
13.	As per the DSS analysis, out of the proposed CA area is (9.75 ha), 07 ha is under the (Moderate Dense Forest-MDF) category. State Govt. shall proposed the revised CA area with canopy density less than 40% and requisite documents (detailed compressive CA scheme with Site inspection of the CA with photographs of the DFO site inspection and trees species to be planted / KML/DGPS map/ Toposheet/land suitability certificate etc.) or explore the 01 ha area adjacent to the proposed CA area with canopy density less than 40%, if available.	The CA site has been revised and accordingly relevant revised documents viz. 17.	Large numbers of trees and sapling (Total 70 no.) including ecologically and economically important species of are proposed for felling. Therefore, possibility of reducing the numbers of trees to be affected may be explored.	The U/A has submitted that at present all the trees proposed in the project are required to be felled. However, every possible steps will be taken during the construction work to avoid the green felling.
18.	State Govt. Shall provide the certificate of non-availability of NFL from Director Land Record the competent authority for proposing DFL under special provision Para 2.2 (iv) of Van (Sanrakshan Evar Samvardhan) Adhiniyam, 1980 and Van (Sanrakshan Evar Samvardhan) Rules, 2023, MoEF&CC.
