Upon finding out a possible violation of the Forest Conservation Act, 1980 in 2022, the field staff immediately stopped the work and issued damage reports in 2023. Determining the exact status of boundaries of the proposed land was delayed due to the absence of boundary pillars. Once the boundaries were clarified, the field staff issued the damage reports. Despite having recovered compensation, warning was issued to the concerned official due to the negligence involved be cautioned in the future. The						

		violation was attributed to unintentional negligence by the field staff, rather than deliberate actions.
