Sub: Proposal for diversion of 310.110 Ha forest land under Keonjhar Forest Division, Keonjhar for construction of Right Main Canal and Distributary of Kanpur Canal System in Keonjhar District by Executive Engineer, Kanupur Canal Division, Jhumpura of Water Resource Department of Odisha. (Proposal No - FP / OR / IRRIG / 40827 / 2019, State Serial No - OR-050/2019, dated 06.07.2019).

Ref: Memo No. 3375 dated 11.02.2021 of Principal Chief Conservator of Forests, Forest Diversion and Nodal Officer, FC Act, O/o the PCCF & HoFF, Odisha, Bhubaneswar and your memo No. 409 dated 15.02.2021.

With reference to the aforementioned memo on the captioned subject, the point wise compliance report of the observations of Principal Chief Conservator of Forests, Forest Diversion and Nodal Officer, FC Act, O/o the PCCF & HoFF, Odisha, Bhubaneswar is furnished hereunder-

1. **To make out exact extent of Forest land involved in the project, the plot wise sabik status of the non-forest land involved in the project as on 25.10.1980, authenticated by Tahasildars concerned may be furnished for each village.**

The user agency has submitted the exact extent of Forest land involved in the project, the plot wise sabik status of the non-forest land involved in the project as on 25.10.1980 and authenticated by concerned Tahasildars is enclosed in the Diversion Proposal vide **Annexure- 3**.

2. **Forest Type & Eco Value Class of the forest land involved in the project is to be mentioned in the Part- II & Site Inspection Report by DFO Concerned.**

Forest Type & Eco Value Class of the forest land involved in the project has been mentioned in the Part- II & Site Inspection Report and enclosed in the Diversion Proposal in page No. 35 to 39 and 68 to 70.

3. **It is seen the few plots having Kissam Gramya Jungle in Hal status has not been taken in to account, while computing the forest land involved in the project. (Example Plot No 709, 717 of Khata No 72 of village Basudevpur under Champua Tahasil. Therefore, the detailed list of non-forest land involved in the project may scrutinized thoroughly and exact extent of forest land may be derived correctly.**

The project proponent has intimated that Plot No 709 and 717 of Khata No 72 of Basudevpur village under Champua Tahasil are non-forest in Hal record and mentioned as Gochar. The user agency has intimated that due to typographical mistake the kissam has been mentioned as Gramya Jungle in the land schedule of Village Basudevpur under Champua Tahasil. Therefore, the total forest land involved in the project is same as mentioned in the land schedule.

4. **The abstract of non-forest land pertaining to Jajaposi village under Champua Tahasil and Solaguda village under Jhumpura Tahasil involved in the project does not tally with the plot-wise detailed non forest land schedule of those two villages reported to have been involved in the project & furnished in the proposal.**

Such discrepancy in case of other villages, if any may also be verified once more to avoid future objection.

The area of non-forest land has been verified in land schedule by concerned Tahasildars and the same has been corrected. The village wise correction of land schedule duly authenticated by concerned Tahasildars is furnished hereunder-



The ORSAC vetted DGPS Map of Bardhana village (Sheet- 02) has been authenticated by DFO and enclosed in the Diversion Proposal.


6. **The documents submitted in the proposal be numbered correctly in serial for easy scrutiny.**
