6. Necessary undertaking with regard to the width of 10 mts to 50 mts strip on either side of public roads and natural streams respectively located inside the mining lease shall be protected, but will not be considered as a part of Safety Zone Area is enclosed herewith as Annexure-V.

8. FRA certificate alongwith the Gram Sabha Proceeding duly issued by the competent authority is enclosed herewith as Annexure-VII.
