 - (ii) In this regard, documentary evidence/ proof of existence of the road before the year 1980 as declaration made by the villagers of Dharjol and Sandoa the Affidavit has already been been submitted vide this office letter No. 10409 dated 10.02.2022. However, photocopy of same is enclosed herewith for ready reference.
- Proceedings of meeting of District Level Committee, Sub Divisional Level Committee and a copy of records of all consultation and meetings of FRC 3. and Gram Sabh of concerned villages have now been uploaded as well as submitted by user agency and enclosed herewith.
- The forest land proposed for CA is DPF named as OD 210.
- The copy of revenue records vis-Jamabandi for the area proposed for 4. diversion for the area proposed for diversion under forest and non forest land 5. submitted by user agency and enclosed herewith.
