

Sir,

I am directed to refer to the above proposal of the State Govt, sent vide No. FRS.26/2000/2 dt. 5.4.2000 seeking approval of the Central Govt in accordance with Section 2 of the Forest(Conservation) Act, 1980.

After careful consideration of the proposal of the State Govt., the Central Govt. hereby agrees in principle for the diversion of 1.99 ha of forest land under Golaghat Forest Division for exploratory oil drilling operation at location NRAA, subject to the fulfilment of the following conditions:-

 The User Agency should deposit the cost of raising compensatory afforestation in degraded forests over double the area to be diverted in favour of the State Forest Deptt.

After receipt of compliance report from the State Govt., formal approval will be issued under Section 2 of the FCA, 1980. Transfer of forest land to the user agency should not be affected till formal orders approving diversion of forest land is issued by the Central Govt.

Compensatory afforestation shall be done at the project cost over double the are in degraded forest land which will be notified as Protected/RF.

The User Agency will establish fuelwood depots and will provide fuelwood to construction labourers and staff, free of cost to avoid destruction to forest area.

The forest area will revort back to the Forest Deptt, when not required by the User Agency. Environmental/Pollution Control measures will be observed as prescribed by the competent authority. (ii) (iv) (v) The forest land should not be used for any purpose other than those mentioned above. (vi)
