2.	Site Inspection Report of DFO Reads that villagers of Chouki & Ratamati are dependent on this proposed land for grazing of fuelwood. Hence the report regarding settlement of their right shall be submitted.	Village Chouki and Ratamati has around 1400 ha. forest land around villages. Of this 7.002 ha. area is being affected by proposed project. So the area being diverted is insignifcant and will not affect the dependence of villagers on forest for fuel & fodder.
