3. The user agency has laid pipeline over 0.2379 ha. of Revenue Forest land in Baripada Forest Division without prior approval under FC Act, 1980. Detailed action taken report on violation of FC Act, 1980 along with name and designation of erring officials responsible for negligence of duties causing diversion of forest land for non-forestry purpose.
