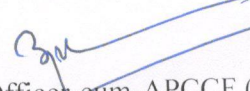

Kindly refer to your office letter No. FC/HPB/06/29/2021 dated 11.04.2022 on the subject cited proposal.

2. The pointwise reply to the observations as raised vide your above referred communication is submitted as below:-

1. (i) The Bill of NPV and Penal NPV has been uploaded against additional information details in online Part-II.
(ii) The user agency has submitted that the road from Bhogpur Simbalwal (kms 0/0 to 3/440) (portion 1/730 to 2/120 and 3/285 to 3.440) was already constructed. The work was started during year 1977 as a footpath track by the Gram Panchayat. The road has been initially constructed by the Gram Panchayat in the year 1990 probably in a length of nearly 200 mtrs & later its formation cutting was completed by the HPPWD during 2001-2002. This case has been listed in approval to cases of construction of road in compliance of directions passed by Hon'ble High Court of H.P. The Hon'ble High Court of HP has given the orders to regularized 2183 roads. The said road has been the Sr. No. 412 in 12th Circle of Nahan. A committee has been formed by the Govt. of H.P. as per the notification vide letter No. dated 24.10.2013 as instructed by the Hon'ble court of H.P. The Joint Inspection was done by the committee on dated 02.11.2015. The Joint inspection report has been uploaded against additional information details in online Part-II.
2. (i) The list of 2183 road provided by HPPWD to Hon'ble High Court of HP constructed in violation of FCA, 1980 highlighting the Sr. No.412 has been uploaded against additional information details in online Part-II.
(ii) The list of roads has been uploaded against additional information details in online Part-II.
3. The aerial distance certificate of Protected Area has been uploaded against additional information details in online Part-II.
4. The user agency has submitted that the all record of consultations and meeting with concerned FRCs and Gram Sabha(s) has been uploaded against additional information details in online Part-II.
