(i) S	anction order/ Approval order of the project from the Competent Authority has not been

furnished.

Sanction order/ Approval order of the project from the competent Authority has been submitted herewith as Annexure-I.

(ii) Undertaking regarding submission of FRA certificate to be to be obtained from the Collector Mayurbhanj district has not been furnished with the DP duly countersigned by the DFO, Baripada Division.

## Undertaking regarding of FRA certificate has been submitted and counter signed by the DFO, Baripada Division (Annexure-II).

(iii) All the topo maps showing proposed natural gas pipeline corridor passing through 2 Nos of Tahasil areas such as Betnoti and Rasgovindpur under Mayurbhanj District, 3 Nos of alternatives routes surveyed by M/s GAIL India Ltd. and the DGPS surveyed forest patches pertaining to different villages under 2 Nos of Tahasils proposed for diversion are to be countersigned by both the DFO and the Tahasildar concerned.

All the topo maps and DGPS maps are signed by DFO and concerned Tahasildar.

(iv) CA Scheme : (1) KML/ Shape file of the CA land identified in Nuagaon RF under Betnoti Range of Baripada Forest Division has not been submitted in the DP.

## KML/ Shape file of the CA land identified in Nuagaon RF under Betnoti Range of Baripada Forest Division has been submitted herewith in the separate CD.

(2) The DFO, Baripada Forest Division has mentioned regarding Bamboo twig fencing around the proposed CA land of about 500 Km in Scheme submitted by him and in the calculation sheet he has taken the fencing of 250RMT per ha. on average which is confusing and needs clarification.

The total periphery of CA land is 881 Rmt instead of previously 500 Km. Now necessary correction has been made in the CA scheme and submitted as Annexure-III.

(3) Regarding watering provision over the proposed Compensatory Afforestation area, the No, of borewell to be installed has not been mentioned in the scheme.

The one no of bore well is required for raising Compensatory Afforestation and necessary calculation has been done in the CA scheme and submitted herewith as Annexure-IV.

(4) The certificate regarding "no plantation has been carried out previously on the identified CA land" has not been furnished by the DFO, Baripada.
