Violation REPORT

A Note regarding the circumstances under which the work has undertaken in violation of Forest (Conservation) Act, 1980.

The Maharashtra State Electricity Transmission Company Limited (MSETCL), Government of Maharashtra Undertaking, has decided to take up construction of LILO132KVYavatmal-Yavatmal MIDC line for 132 KV Darwha S/Stn Transmission for augmentation of the electricity grid network towards increasing demand of power in the Yavatmal & Darwha region.

The total length of the project stretch selected for construction of the line is 36.5 Km. Part of this line of length 166.5 mtr. is passing through reserved forest area of Gut No. 31, Compt. No. 96 of Village Pandhurnain Yavatmal Forest Division. P.O.R. for the same proposal is issued with no. 128/16 dated 26/11/2020. The proposed line requires diversion of 0.45 Ha in Yavatmal Forest Division. Therefore the construction of this line requires forest clearance from Ministry of Environment Forest and Climate change (GOI).

The diversion of reservedforest area has been limited to the minimum that satisfies the standards of Central Board of Irrigation and Power. As the project line is passing through the middle of thereserved forest area, avoiding reservedforest area is not possible. Alternatives has been examined and found that no better option is available.

The construction of this line is commenced in year 2017 and no construction activities have been conducted in the forest patch. During stringing work of transmission lines, 166.5mtr length of forest patch is violated with the said overhead transmission line. There are no tower foundations within this land. Details of violations are as follows.

The work in this area is stopped and proposal for approval under Forest (Conservation) Act 1980 is submitted by the Project Authority.

The project authority has given undertaking to bear the cost of Compensatory Afforestation as directed by Forest Department.

As the proposal is for construction of transmission line and there is no suitable alternative for the same and project authority has submitted the proposal for obtaining approval from Government of India. Gut No. 31, Compt. No. 96 of Village Pandhurna is reserved Forest

as per this office record, the proposal is recommended subject to agency shall pay penalty for violation equal to Net Present Value (NPV) of forest land per hector for each year of violation from date of actual diversion reported in violation report of MSCTCL, with maximum upto 5 (five) times the NPV plus 12% simple interest till the deposit is made.
