3. Geo-referenced maps of forest land proposed for diversion and land for compensatory afforestation have been uploaded in the online proposal and copies of same are placed in the hard copies of case file also by the user agency.
4. Geo-coordinates of land proposed for diversion and land for compensatory afforestation have been provided in the online proposal as well as in hard copies by the user agency. Topo sheets have been provided on a scale of 1:50,000.
5. Seal of Collector has been got on the FRA certificate.
6. The available documents in original have been provided in one of the files.
7. Title and table have been provided on the topo sheet of land for CA.
8. Calculation of NPV has been checked again and same is found to be correct.
9. The documents have been signed by user agency with name, seal and date.

The corrected proposal as above is submitted enclosed herewith. It is requested to kindly process the proposal further for approval of Government as per the provisions of Forest (Conservation) Act, 1980.
