Compliance Statement of Point 3&4 is as below: Observation 3: The land schedule provided from page 38 to 39 does not provide for balance of RoW at various change, why varying width has been adopted at various chainages has not been explained in the proposal. Compliance: Existing ROW varies from 12 - 30 m & proposed COI varies; 12m in settlement area and 20m in open / rural area. The varying width has been considered to minimise the R&R issue in settlement areas. Existing RoW is limited to 12m at some of the locations; also, the road formation at these locations has been kept to 12m. Therefore, no balance land is being remaining at these

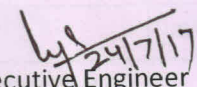

The enumeration list provided with the proposal mentions correct number of trees affected i.e. 1,434. In the online uploaded list due to double entry of a single specie, that discrepancy arised, which has been rectified.
(b)	Details of poles (gbh < 30cms) and plants in proposed forest land has not been provided.	Details of poles (gbh<30 cms) and plants has been enclosed with the revised proposal.
