

9	The information given in para -8 (ii), (iii) and (iv) of online Part II regarding the projects area being part of national park, wildlife sanctuary, biosphere reserve, tiger reserve, elephant corridor, wildlife migration corridor etc is confusing and lacking in clarity. The information may be reviewed and re-submitted along with comments of the Chief Wildlife Warden, if required.
