The Compensatory Afforestation Scheme has been reviewed and revised as well keeping in view the Norms for plantations and maintenance of old plantations for Non-Tribal and Tribal Areas for the year 2022-23 approved by the Pr. CCF (HoFF), HP and uploaded online on Parivesh portal in the Part-II, please:
3.	As this project is no site specific category, therefore, comments of DFO concerned should be furnished in view of Para 1.2 of FC handbook guidelines.	In this respect, the User Agency has submitted the detailed justification that the Police Post, Jutog is under the jurisdiction of the Police Station West, Shimla. The population of this area as per the census is about 60,000. Further, the site is adjoining the National Highway i.e. Shimla to Nalagarh and Shimla to Dharamshala and there are many Government offices nearby i.e. Four Banks i.e. SBI, Cooperative, HDFC and PNB, senior Secondary School, Tuto, Primary Health Centre and two MC Wards and the same site is between MC ward, Cantonment Board and 13 Gram Panchayats due to which the proposed project cannot be established away Cantonment Board, Jutog.
