Kind attention is invited to the subject and references cited above.

It is submitted that the processed proposal for diversion of 1.1221 Ha (revised from 1.4637 Ha) of forest land to grant necessary permission to execute the road work from 0/500 to 2/2452 Kms for providing BT Road from Rayadhari to Godumalla via Pochampally (V) of Pembi (M) of Nirmal District in favour of Executive Engineer, Tribal Welfare, Division, Utnoor District, was submitted to the IRO, MoEF&CC, Gol, Hyderabad by State Govt vide ref 5th cited.

The IRO, MoEF&CC, Gol, Hyderabad vide ref 6th cited has returned 11 proposals (the subject proposal is one among them) which were submitted to them **after 28.06.2022**, with a request to process the same as per the provisions of FC Rules, 2022.

Accordingly, User Agency was requested to take immediate necessary action in submission of proposals as per the provisions of FC Rules, 2022 vide ref 7th cited.

As the case is such, the MoEF&CC, Gol, New Delhi vide Ir.dt.14.11.2022 has issued guidelines w.r.t processing of proposal pertaining to proposal uploaded on Parivesh 1.0 for want of availability of complete end to end functionality of FC module in Parviesh 2.0 as per the FC Rules, 2022.

As per para 3 (i), of the said guidelines.

".....proposals submitted in PARIVESH 1.0 after 28.06.2022 and not migrated to PARIVESH 2.0, may be processed using the FC module of PARIVESH 1.0. However to adhere the procedures laid down in the Forest (Conservation) Rules, 2022, the minutes of the meeting of Project Steering Committee (PSC) may be attached with part-IV of forms and passing of proposals of less than 5 ha through Conservator of Forests, may be treated inert for procedural/ technical purposes...."

As per para 3 (iii), of the said guidelines.

".....proposals, already submitted in the PARIVESH 2.0 at various levels, may be processed in offline mode by the processing authorities of the State/UT concerned following the statutory process provided in the Forest (Conservation) Rules, 2022...."

In this particular case, the proposal has already been submitted to IRO, MoEF&CC, Gol, Hyderabad in Parviesh1.0 and as per the para 3 (i), proposal can be processed now and as the area recommended by the DFO / CF is less than 5.00 Ha, this proposal is not needed to be placed before the PSC meeting..

In view of the facts mentioned above, the State Govt. are requested to forward the above replies to the Gol, MoEF&CC, Hyderabad for according necessary approval for the project.
