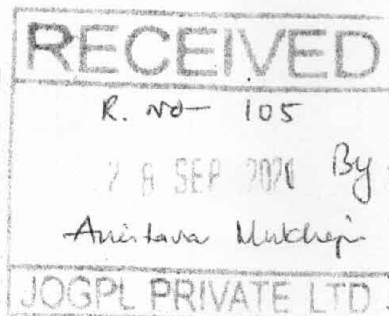



I am directed to refer to your letter no. F.1-2(46)/GEO/D1/2009/17175-76 Dated 26.09.2015 on the above subject and to convey the prior approval of Government of India for the grant of Petroleum Mining Lease (hereinafter referred to as "Lease") under Rule 5(1) (ii) of the Petroleum & Natural Gas Rules, 1959 (as amended from time to time) to M/s Jubilant Oil & Gas Pvt. Ltd & GAIL (India) Limited in respect of Block AA-ONN-2002/1 for the above said area bounded by the geographical limits as per Appendix 'A' and to state that the lease shall be subject to the following terms and conditions in addition to such other terms and conditions as agreed upon in the deed /agreement signed, if any, in respect of the said area:-


1. The lease shall be in respect of Crude Oil and Natural Gas.
2. The lease shall be valid for a period of 20 years.
3. The lease shall be subject to the provisions of Oil Fields (Regulation and Development) Act, 1948, (53 of 1948) and the Petroleum & Natural Gas (P&NG) Rules, 1959 made thereunder as amended from time to time.
4. Royalty on Crude Oil, Condensate and Natural Gas shall be payable by the lessee as per such rates as may be fixed, from time to time, by the Central Government in consultation with the State Government. The royalty shall be payable on monthly basis and shall be payable by the last day of the month succeeding the period in respect of which it is payable.
5. The lessee shall, as soon as possible, provide the Central Government or its designated agency, free of cost, all data earlier obtained or to be obtained as a result of petroleum operations under the lease as specified in Rule 19 (c) of the P&NG Rules, 1959, as amended from time to time.
6. Necessary approval from the Competent Authority should be obtained for the Reserve Forest Area (if any) falling in the leased area.
7. If international companies or foreigners are entrusted with the task, the lessee may get security vetting of these companies through the appropriate Government agencies with the help of this Ministry. The lessee shall also seek prior clearance from the Ministry of Home Affairs and Ministry of Defense with the full particulars of the foreigner employees under intimation to this Ministry.
8. The lessee shall issue identity cards to each of the employees. The system of checking identity cards of personnel will have to be strictly enforced.

9. Security to its employees both at the project sites and en-route in insurgency-affected areas will be the responsibility of the lessee.
10. The lessee shall allow Government authorities to enter and inspect area for security check-ups, if necessary.
11. Lessee shall not employ any foreign national surreptitiously in the areas along the border.
12. No ground / aerial survey of the Defense Vulnerable Area/ Vulnerable Point are permitted. Aerial survey, if any, would be governed by the provisions of Ministry of Defense letter no. 18 (8) /82 - D (GS 111) dated January 31, 1989.
13. Air force areas falling within the zones earmarked for delineation should be avoided.
14. For work in close vicinity of Indian Air Force units / Installations and visits to these installations, if any, specific permission of Air Hdqrs. should be obtained.
15. Any work within 500m of the perimeter of Air Force Station should be intimated to Air Force authorities at least 10 days before commencement of the activities.
16. No obstruction shall be erected higher than 15 mtrs within 5 kms. radius of Air Force Air Fields and construction of any high mast / towers shall be carried out in consultation with the Air Force Authorities.
17. Lessee shall execute a separate lease deed in respect of such other covenants, terms and conditions as per the prescribed format.
18. In case the production of oil/gas ceases permanently from the field, the DGH and the Ministry may be informed immediately.

With reference to correspondence cited above, the undersigned hereby submits the reply to additional information sought by DIGF(C), IRO Shillong as point wise.

2. Justification on the recommendation of State Govt that the user agency shall bear the expenditure to document the biodiversity and tents for protection unit as the Muhuripur RF had good biodiversity and needs effective patrolling by protection unit.

Justification: a. Purchase of Equipment for Documentation of Biodiversity

In South Tripura, Muhuripur Reserve Forest forms major part of Bagafa Forest Subdivision, the forest comprises good patches of Sal, Garjan and other species including rare flora such as Hijal, Raktanchan, Menda, Haiud, Gandharaj, Gang Jarul etc. Faunal species sighted are Phyre's Leaf Monkey, Snakespp, Pheasants, Civet catspp, Mongoosespp, Leopard cat, hornbill & others. The field level staffs and villagers nearby forest claiming the presence of Binturong and Fishing Cats. Though the forests are rich in biodiversity, there are no records such as identification & documentation of species are available. This may be due to non-availability of equipment such as Camera Trap, Live Camera machine, DSLR Camera in Range Office and publication of books(based on identification & documentation) on Muhuripur forest.

Therefore, the state government recommended that the user agency may bear the expenditure for purchase of equipment such(Camera Trap, Live Camera machine and DSLR Camera in Range Office) and publication of books documenting the biodiversity. The undersigned hereby recommend that the user agency may bear tentative expenditure of Rs.4,00,000/- (Four Lakh) only for equipment purchase & Rs.1,00,000(One Lakh)-/- for publication(documentation) of the above said objective.

Justification: b. User agency shall bear the expenditure of tents and other equipment for Protection Unit to protect the Muhuripur forest.

Ltd.

The field inspection was done on 11/5/2023 along with SDFO Bagafa and his field staffs. The forest land measuring 2.74 ha selected for CA plantation lieu proposal for diversion of 1.368 Ha of forest and for construction of drill site, waste pit, drill site accommodation oil, TSR camp and its approach at Location Dev-2 at Mouja



Birendranagar under South District of Tripura by Jubilant Oil & Gas Pvt. Ltd. is **found to be**

suitable for taking up of Compensatory Afforestation.



The site is close to private land having rubber plantation. This selected forest land degraded and open and found to be vulnerable to encroachment. The site is

covered with weed growth. Immediate fencing work could be taken up for protecting the land from encroachment.

Thus, based on the observations made during the visit, it is to certify that the same site selected for CA plantation is recommended for Compensatory Afforestation.

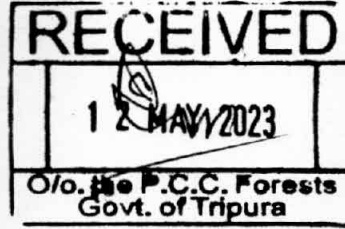

Reference is made to your letter dated 27 April 2023 enclosing letter dated 24 April 2023 from IRO, MoEF & CC Shillong wherein JOGPL has been requested to submit reply on IRO observations at Serial No- 1,4,5,6,7,8,9.

The point wise response to IRO observations are as under:

- Observation 1:** This proposal is under PEL for Block AA-ONN-2002/1 for an area of 1260 sq km with period from 07.06.2014 to 06.06.2015. The State Govt may clarify the grant of PML before drilling and whether in this case PML is required.
Response: The location falls under 249 sq km PML area now. The PML has been granted by Government of Tripura, Department of Industries & Commerce vide letter dated 24th September 2020. A copy of the letter is attached as **Annexure-1**.
- Observation 4:** The employment generation mentioned in the proposal is 0 nos. permanent / regular employment & 20 nos. temporary employment. The State / User Agency may kindly clarify in terms of man days.
Response: A) During Construction Phase, the Civil Works and Drilling Operations will be carried out by third party contractors who will bring its own manpower. User Agency will temporarily hire about 15 people for site maintenance and miscellaneous work for the expected construction duration of 90 days. The mandays will be 1350.
B) During Operational Phase, about 5 No temporary manpower will be hired for site maintenance amounting to 300 mandays/year.
- Observation 5:** The copy of Forest Right Act, 2006 certificate submitted is not clear / legible. The same to be resubmitted clearly certifying the area along with the location.
Response: A copy of Forest Right Act, 2006 certificate is enclosed as **Annexure-2**.
