Sub : Forest (Conservation) Act, 1980 – Dharmapuri Circle / Wildlife Warden, Hosur Forest Division, Hosur – Proposal for diversion of 0.9856ha of forest land in Ayaranapalli village for erection of 110KV Transmission line from Rayakottai – Kelamangalam road to TATA Electronics Company in Ayaranapalli village in Krishnagiri District - Regarding.

I submit to state that, as per the shortcomings raised by the Principal Chief Conservator of Forests (Head of Department), Chennai in the Ref (2) cited above, the User Agency has uploaded the reply in the web portal "Form A of Part I – Additional information details".

Based on the reply submitted by the User Agency, the following details is furnished below.

1. In the proposed site, there are two Towers proposed to be erected i.e. (1) Loc 4 KCR + 6m Tower and (2) Loc KCR Normal Tower and the height of the proposed towers is 32.235m and 26.235m respectively. The specifications of the towers has been clearly mentioned by the User Agency in the reference (4) cited above.
2. There are two Towers to be erected in the proposed site.
3. The minimum ground clearance proposed below the sagging proportion of the proposed Transmission Line is as detailed below;
 - a. Between Tower Loc 3 to 4 = 14.35m
 - b. Between Tower Loc 4 to 5 = 8.10m


Further, I submit that, the Wildlife Mitigation Measures Plan for an amount of Rs. 765.00 lakhs was approved by the Principal Chief Conservator of Forests and Chief Wildlife Warden, Chennai vide Ref. No. WL5 / 33675 / 2022, dated.11.11.2022 for this project. The copy of the same is uploaded in the web portal "Part II – Additional information details" and the copy of the Wildlife Mitigation Measures Plan is enclosed herewith for further process of the proposal.

Therefore, under the above circumstances, I submit that the proposal for diversion of 0.9856ha of forest land in Rayakottai Range of Hosur Forest Division for erection of 110KV Transmission line from Rayakottai-Kelamangalam road to TATA Electronics Company may kindly be submitted for getting the concurrence of the Government of India.
