

i	Division wise density of all 38 forest patches involved in the proposal has not been provided in the proposal.	Division Wise density of Reserved forest & Protected forest are available in Stock map as well as in compartment history of Division so, the same have been submitted with proposal. The density of Revenue forest land is not in practice to be maintained by the Revenue Department as well as by forest Department. Thus the same are not available, but they are degraded area. Further the density of trees on the basis of actual No of trees per patch which is under the corridor of 27 Mtr. width as per area of affected forest patch have been worked out and enclosed herewith for ready reference as Annexure-I .
ii	KML files for 38 patches of the forest land involved in the proposal have been submitted. However, single KML file for the entire stretch of transmission line may be submitted for the ease of analysis of the forest area using decision support system.	line is attached in the CD for analysis of forest area. (CD Enclosed).
iii	From the examination of the vegetation map, it is observed that alignment at tower no. AP13 and AP12: AP 26 and AP 27: and AP 68 to AP67 is passing	The vegetation map is plotted on the basis of Geo Co- ordinate of the Angle point (AP) of transmission line, which was gathered during DGPS Survey of line.

AP 78 and AP78 to AP83, passing through the moderately dense forests in Bijapur Forest Division which can be avoided by affecting a slight shift in the alignment. The Comments of the State Government on the possibility of shifting the alignment may be submitted along with the forest stock maps showing the alignment conspicuously along with proper legends.

Between AP 12 to AP13 the line is not passing through PF 1312P. The line corridor is 24.1 Mtr. away from the boundary of compartment 1312P where in the vegetation map line is passing though 1312P.

Between AP 26 to AP27 the line is not passing through any RF / PF compartment as indicated on vegetation map.

c. Between AP 67 to AP 68 the line is not passing through the any RF / PF or OA 1084 compartment. The line corridor as 6.0 Mtr. away from the boundary of compartment OA1084 where as in the vegetation map line passes though OA1084.

d. Between AP 80- to AP 78 the line passes along the National highway through the lantana/ Bamboo forest. Further between AP78 to AP83
at the bank of Mingachal river adjacent to the road Police Base Camp is established, So the route of the line could not be changed

In view of above, it is submitted that if line would have been shifted in any direction that positively affect the involvement of forest land as well as the number of Trees. Therefore it is proposed to keep the line on existing route without any change.

It is clarify that, due to project under forest division Dantewada 5206 no. and under forest division Bijapur 927 no. of trees, total 6133 Trees shall be affected in 27 meter corridor of proposed line, and the same has mentioned in the forwarding letter as well as in document submitted in proposal, under checklist-12. It could be seen at proposal the girth wise affected trees are 5206, 927 and total 6133 Nos. respectively for forest division Dantewada, Bijapur and consolidated statement is mentioned for both division at check list 12, Form1a.

Regarding the No. of trees those has been mention in para-4 i.e 62 and 72, it is clarified that these figures are indicating against abstract of "Total number of affected trees per Hectares in 27 meter corridor of line" under check list 12 form 1b for forest division Dantewada and consolidated statement. And these average figure cannot be added in the total affected trees account.

Further, documents pertaining to the density of vegetation in Dantewada and Bijapur District, mentioned as 0.5 to 0.7 and 0.5 respectively and the state government mention the same as 0.4 to 0.8 and 0.4 to 0.5 respectively. Here, it is submitted that the average vegetation density of forest compartment as per old stock map, record and quality class wise are 0.4 to 0.8 and 0.4 to 0.5 respectively for forest division Dantewada and Bijapur.

The existing 33KV line was erected on cement/ Steel poles and this line is utilized for distribution of power of several 33/11 KV distribution sub station in accordance with to the existing distributed load points and this line is drawn accordingly, not directly between Barsoor and Bijapur. This line is constructed from Barsoor to Bijapur.

iv The State Government in its forwarding letter has mentioned that a total of 6,133 trees will be affeeted from the project while the underlying documents mentioned total number of trees as 6,267 (5206+927+62+72). Exact details of project affected trees, Division wise may be submitted by the state Government. Further underlying documents pertaining to density of vegetation in Dantewada and Bijapur Districts mentions the density as 0.5 to 0.7 and 0.5 respectively while the State Government mentioned the same as 0.4 to 0.8 and 0.4 to 0.5. Exact vegetation density may be communicated by the State Government.

V As per the details indicated in the proposal, the existing line of:~.33" KV from 220 KV Barsoor -Substation is supplying power to the Bijapur. The rationale for proposing altogether new alignment originating from the same Sub-station through the

	33KV switchyard of EHV grid s/s and this line will be functioning from Barsoor and Proposed Bijapur S/s even after construction of proposed 132 KV Barsoor Bijapur line, which is constructed for 132/33 KV s/s Bijapur. So, this 33KV line cannot be upgraded as 132KV. Further the route of this transmission line is in such a manner wherever possible transmission line has been proposed along with the existing 33 KV line and existing 33KV line has been kept inside the corridor of proposed 132 KV line (in 27 meter corridor) specifically in forest area between AP1 to 2, AP4 to 6, AP25 to 26, AP36 to 37, AP47 to 60 AP67 to 70, AP78 to 80.
vi	Examination of the kml/shape files, it is revealed that out of total area nearly 87.10 % falls under the category of moderately dense forest while only 13.09% appears to be fit for afforestation. The State Government therefore, needs to re-confirm the suitability of the area proposed for CA and if required alternate CA site suitable for afforestation may be selected. Further, as per the provision of the component of CA scheme, the State Government has incorporated the provisions further needs to be elaborated to confirm if the provisions of protection incorporates watchman and fencing also as the same appears to have been provided only for 2 months.

vi	ii Revised suitability certificate in respect of CA that may be obtained from the DCF clearly certifying the status of encroachment and encumbrances on the degraded forest land proposed for CA.
