Kindly refer the letters cited above. Ministry of Environment, Forest and Climate Change, GOI, New Delhi, vide letter referred at serial no.1 has directed to provide list of existing mining leases executed on or before 11/01/2017 involving forest land along with the proposals under Section-2 (ii) as well as Section-2 (iii) of FC Act, 1980 duly recommended by the State Government which needs to be considered.

Accordingly, the Additional Principal Chief Conservator of Forests & Nodal officer, Nagpur, vide letter referred at serial no.2 has submitted the requisite information. The information provided by Nodal Officer, Maharashtra State, Nagpur is forwarded herewith for early needful action in the matter. (Annexure-1)

In addition to this, Ministry of Industries, Energy & Labour Department, Government of Maharashtra has conveyed that, mining lease is not sanctioned in 21 cases, in which Forest Clearance under Section-2 (ii) & (iii) of FC Act, 1980 is not obtained. (Annexure-2) However mining lease is sanctioned to M/s. Shivram Minerals, Kolhapur over an area of 576.12 Ha. (Non Forest Land-243.71 Ha. + Forest Land-332.40 Ha.) for a period of 30 years for Bauxite Mineral of 22nd April, 2002. Now, M/s. Shivram Minerals, Kolhapur have submitted the fresh proposal b

reducing the Forest area up to 61.00 Ha. under Section-2 (iii) of Forest (Conservation) Act, 1980 to the State Government, which is under consideration.
