However, as per the working plan the same area is recorded as D-113 Suki gad New DPF. The confusions has only arisen due to non-reconciliation of the forest and revenue records, otherwise the CA area has not been changed.

		The kacha track visible within CA Land is a temporary track to the water tank there. The track is minimally used. Furthermore, an alternate foot track is also available to access water tank from Lambidhar which is outside of proposed CA land. Thus, the presence of the track will not hamper the plantation area in any way.
