Proposal for Diversion of 26.994 Ha. Forest Land for construction of Four Lane dedicated Coal Corridor from Bankibahal (Coal Mine)0/00km to Bhedabahal(SH-10) 30/811 Km. in the District of Sundargarh by Executive Engineer Sundargarh (R&B) Division, Sundargarh.

In pursuance of your aforecited Memo on the captioned subject, the DFO, Sundargarh Division vide his Memo No.9053 Dtd.20.12.2019 and copy endorsed to you in the next Memo of even date has submitted the point-wise compliance with the observations which may kindly be perused.

The point-wise compliance based on the report of the DFO, Sundargarh Division is as follows:-

1. UA has not signed the check lists.

As reported by the DFO, Sundargarh Division, the Executive Engineer (R&B) Division Sundargarh has submitted the signed copy of check list, which is enclosed at **Page-1-6 in the DP**.

2. Tree enumeration differs in non-forest Government and non-forest Private land in Site Inspection Report and general abstract of trees.

As reported by the DFO, Sundargarh Division, the nos. of trees enumerated in Non-Forest Govt land is 1706 where as in private land, it is 2342. The corrected tree enumeration list of Non-Forest Govt. land and Non-Forest private land is enclosed at **Page-182 in the DP**.

3. CA Scheme is to be revised at current wage rate of Rs.298/- per MD.

The DFO, Sundargarh Division has submitted the revised CA Scheme at the current wage rate of Rs.298.00 per man day with the total and the total financial outlay of Rs.1,56,88,118/- which is enclosed as **Annexure-C/DP**.

4. KML/ Shape file of CA land not furnished.

As reported by the DFO, Sundargarh Division, the Executive Engineer (R&B) Division Sundargarh has submitted the KML/ Shape file of Compensatory Afforestation land in a **CD** which is enclosed **DP**.

5. (a) In the Form-A (Part-I), it is mentioned that the total non-forest land required for the project is 119.52 ha. (Page No.11/DP).

As reported by the DFO, Sundargarh Division, the Executive Engineer (R&B) Division Sundargarh has intimated that, in the Form-A (Part-I), it has been mentioned that, the total Non-Forest land required for the project is 119.52 ha. (Page No.11 in DP).

(b) Further, in Form-A (Part-1), the village wise break-up of non-forest land is 116.287 ha.

As reported by the DFO, Sundargarh Division, the Executive Engineer (R&B) Division Sundargarh has intimated that, in the Form–A (Part-I), after totalling, the village wise break-up of Non-Forest land comes to 119.52 ha which has been corrected accordingly.

(c) In Page No.12/DP, the purpose wise break-up of non-forest land is

119.4972 ha.

As reported by the DFO, Sundargarh Division, the Executive Engineer (R&B) Division Sundargarh has intimated that, the total of the Purpose wise break-up of Non-Forest land is 119.52 ha. and accordingly the corrected copy of Form-A (Part-I) is enclosed at **Page No12/DP** and uploaded in the portal by the User Agency.

(d) The total of non-forest land at Page No.59 to 163/DP comes to 115.958

ha.

As reported by the DFO, Sundargarh Division, the Executive Engineer (R&B) Division Sundargarh has intimated the total Non-Forest land comes to 119.52 ha. which is enclosed at **Page No.59 to 168 / DP.** 

(e) The status of coal bearing area of Basundhara Coal Field area of MCL over 4.30 ha involved this project as on 25.10.1980 may pleased be furnished.

As reported by the DFO, Sundargarh Division, the Executive Engineer (R&B) Division Sundargarh has submitted the status of coal bearing area of village Bankibahal and Balinga over 4.30 ha. involved in this project as on 25.10.1980 given by the Tahasildar, Hemgir which is enclosed as follows:

(a)-Bankibahal Private land at Page No.73-74 / DP.

(b)-Balinga Private land at Page No.76 / DP.

(c)-Bankibahal Govt Land at Page No.75 / DP.

(d)-Balinga Govt. Land at Page No.77 /DP.

NoC from MCL should be obtained to use 4.30 ha of Non-Forest land for construction of the road.

As reported by the DFO, Sundargarh Division, the Executive Engineer (R&B) Division Sundargarh has obtained the NOC from MCL, Basundhara area for use of Coal Bearing Area for construction of road, which is enclosed at **Page No.78 in DP**.

The diversion proposal along with KML file in CD form re-submitted by the DFO, Sundargarh is forwarded herewith in quadruplicate for further action at your end.
