Subject: Diversion of 0.6806 ha. of forest land in favour of Sanjeev Hydro Projects Private Limited VPO Sauhora, tehsil & district Kangra for the construction of Lower Iku Small Hydro Project, within the jurisdiction of Dharamshala Forest Division, District Kangra H.P.


2. The point wise reply to the observations furnish as under :-

- i. The area proposed for Dumping Sites is barren land and no trees are standing on the area. The area proposed for Dumping Site are as such selected that barren land and involves no felling of trees.
- ii. The Plantation Scheme for 1360 plants in 1.360 hac area is enclosed herewith in triplicate.
- iii. The Muck Dumping Plan has been authenticated and is enclosed herewith.
- iv. As submitted by the User Agency, the area proposed during the submission of Feasibility Report are tentative. The area proposed for the Project are finalized after conducting the Detailed Topographical Survey during the preparation of DPR, so there is difference in the area proposed in Feasibility Report (FR). The area proposed 0.6806 ha is barest minimum required for the construction of above cited Project.
- v. As submitted by the User Agency, they have submitted an application to Project Director Himurja being Nodal Agency, for information regarding steps taken to minimise the ill effects on Environment and the Criteria followed for Allotment of such Projects. The Project Director Himurja has asked the Directorate of Energy (DoE) for the necessary information. Being Policy matter, this has to be dealt on higher level, which may take time. This information has been asked by MoEF in Forest Proposals and the information which will be supplied by the DoE will be applicable to all Projects upto 25 MW. So the User Agency has request that the proposal may be considered for In-principle approval. The User Agency has assured that they will abide by all the stipulations / conditions, if any imposed by Government / Competent Authority as applicable.

- vi. As submitted by the User Agency, the FRA Certificate is under process. The User Agency has submitted that the FRA Certificate will be provided before the Final Approval of the Proposal. An Undertaking in this regard is enclosed herewith.
- vii. The User Agency has uploaded the copy of Techno Economic Clearance (TEC) and Implementation Agreement (IA) and copy of same is enclosed herewith in triplicate.
- viii. The User Agency has uploaded the copy of Detailed Layout Plan and same is enclosed herewith in triplicate.

It is therefore, requested that the necessary approval for the diversion of 0.6806 ha of forest land for the construction of above mentioned project may kindly be obtained from the Govt. of India under Forest (Conservation) Act, 1980 and conveyed to this office.
