Sub: Diversion of 5.117 ha of forest land for Construction of Koraput-Singram Doubling Railway Project from 0.000 Km to 74.800 Km under Koraput Forest Division by East Coast Railway, Visakhapatnam, Andhra Pradesh in Odisha. – Govt. of India observations dated 08.12.2023 regarding.

Ref-: Letter No. 5-ORC617/2023-BHU dated 08.12.2023 of the Deputy Inspector General of Forests (C), GoI, MoEF & CC, Regional Office, Bhubaneswar.

Sir,

Apropos to the above mentioned subject, it is to inform that the Govt. of India vide letter under reference has requested to identify equivalent non-forest land for raising CA and submit details of CA Scheme along with relevant maps and KML file instead of double degraded forest land identified earlier as the provisions of FC Rules, 2022 shall apply to the instant proposal.

In this context, it is to reiterate that the user agency i.e East Coast Railway, Vishakhapatnam, Andhra Pradesh had applied for the proposal online through Parivesh 1.0 on 18.04.2022 and subsequently observations (eds) were raised by the Nodal Officer after due scrutiny on 20.04.2022 and 20.01.2023 to the user agency for compliance. The user agency complied the observations and resubmitted the compliance online to the Nodal officer on 17.01.2023 and 20.01.2023 respectively. Further, the Nodal Officer accepted the proposal on 20.01.2023. The State Serial number was generated on 08.02.2023 and forwarded to the DFO, Koraput division for processing of Part-II.

The proposal was subsequently received from RCCF, Koraput online on 21.10.2023 after Part-III by the Nodal Officer which was forwarded to the State Government on 10.11.2023 and on 18.11.2023(compliance of observations). The said proposal was forwarded to the GoI, MoEF & CC, Regional Office, Bhubaneswar on 20.11.2023 by the State Government. The details of Timeline downloaded from Parivesh 1.0 is enclosed as Annexure-I.

In view of the above, it is pertinent to mention that since the online proposal was initially received on 18.04.2022, the processing was done as per extant Rules and Guidelines in force under FC Act, 1980. Accordingly, twice the degraded forest land over 11.0 ha was identified in Hatimali DPF under Laxmipur Forest Range of Koraput Forest division which has been approved by the Nodal officer and submitted to the State Government alongwith the proposal.

Further, it is to mention that the Forest (Conservation) Rules, 2022 came into force with effect from 28.06.2022 and the instant proposal was received initially online through Parivesh 1.0 on 18.04.2022 i.e prior to implementation of FC Rules' 2022 and processed accordingly.
