With reference to the subject cited above and your letter quoted above, I am submitting herewith the additional information/ clarification sought vide your letter under reference as below for your perusal and onward action.

<b>Govt. of India letter No. 3-AS B 088/2017-SHI/140- 41,dt. 10/04/2017</b>	<b>Information Provided</b>
Point No. (i)	The distance of proposed diversion area is about 12kms from Dehing Patkai Wildlife Sanctuary, as reflected in the Site Inspection report of the Conservator of Forests, Eastern Assam Circle, Jorhat and not 7.5 km as mentioned in the forwarding letter through oversight.
Point No.(ii)	As the area is less than 1.0 ha. the shape file and KML file will not be applicable as noted below.
Point No. (iii)	As the proposed area for diversion is less than 1.0 ha., as such C.A has not been insisted upon as per clause No. 3.2(viii)(b), hence the desired Chief Secretary certificate of non-availability of non-forest land for CA will not be applicable. The CA proposal and estimate against the Proposal No. FP/AS/THE/8413/2014 furnished to you through oversight may kindly be treated as withdrawn.
Point No. (iv)	The diversion area and the Compensatory Afoorestation area both falls in Compartment No.9 of Jeypore Reserve Forest under Dibrugarh Division.
