Diversion of 23.80 Ha. of forest land (as per Sabik records as on 25.10.1980) including 2.240 ha. of forest land in safety zone area of Chromite ore mining from their Kalarangiatta Chromite mines by M/s Ferro Alloys Corporation Ltd. (FACOR Ltd.) in Cuttack Forest Division coming under jurisdiction of Sukinda Tehsil of Jajpur District, Odisha.

In inviting a kind reference to the correspondences cited above on the captioned subject, this is to inform that the deficiencies raised with regard to Compensatory Afforestation land was intimated to the User Agency i.e. M/S FACOR Ltd. for compliance vide this office Memo No. 3467 dt. 17.04.2018. In response, the User Agency has submitted the DGPS Map duly authenticated by ORSAC. The User Agency has submitted a detailed report to the undersigned indicating that an area of 11.318 ha is already broken up prior to 1980 of M/S TATA Steel Ltd & Safety Zone area is 2.240 ha. Accordingly, the area required for Compensatory Afforestation is $\{23.80 \text{ Ha.} - 11.318 + 2.240\} = 10.242 \text{ Ha.}$ The User Agency has superimposed the lease boundary map of Kalarangiatta Chromite Mines over the broken up area of M/S TATA Steel Ltd. & found that about 11.318 Ha. of Kalarangiatta mining lease area had already been broken up by M/S TISCO Ltd. prior to 25.10.1980.

In enclosing here with the detailed compliance report submitted by the User Agency along with superimposed map & shape file in CD duly authenticated by ORSAC and signed by Divisional Forest Officer, Cuttack Forest Division & Dy. Director of Mines, Jajpur road, it is requested to consider the case of the User Agency and the User agency may be allowed for CA over 10.242 Ha.
