In this context the point wise reply of the observations has been attended by this office and furnished as under:

1	There is variation in temporary employment detail as mentioned in Part-I of the proposal Against column No. 1 (vi), temporary employment has been mentioned as 1500 man-days whereas in online Part-I, it has been mentioned as 5000 man-days.	Needful has been done by User Agency in Online Part (I). 15000 thousand Man-days would be generated from construction of this road. Now the figure as mentioned in Part-I of proposed tallied with the detail filled in online Part – (I)
2	In the site inspection report as placed in the proposal folder, the column No. 6 (b) has not been marked. As the violation has been done by the user agency or villagers, therefore, column No. 6 (b) should be marked by the DFO concerned with appropriate comments	Needful has been done. The undersigned has filled the column No. 6 (b) with appropriate comments.
3	Against column No. 11 (i) b, of online Part-II, the period of violation be corrected. As the violation has been done long back in 1970 by the villagers. Therefore, it is clear that violation has been done 52 years ago. The period of violations be corrected accordingly.	The correction have been done in online Part II
4	In online Part-II against column No. 14, the progress of compensatory afforestation has been shown up to 14.03.2022 whereas in Part-II of the proposal folder, the progress of CA has been shown up to 28.02.2022. It must be shown up to 14.03.2022 in Part-II of the proposal folder. The forest land over which CA has been done has been also shown as nil but in	Needful has been done and also as per checklist No.17 at page No. 43 the CA has been shown over 3.13 hac. Area as uploaded in online Part II

	online Part-II. it has been shown as 71.438 hectare	
5	The detail of population to be benefited along with the detail of villages and there code has been found placed in the proposal folder at P.No. 53. It must be uploaded in online Part-II also.	Population to be benefited Certificate Uploaded in Part (II) as Additional Documents.
