Permanent structures are present in the non forest land which were present are part of a plot basically a room and boundary of the plot has been made. Site had been visited on 23.05.2018 and it was found that there is no violation has been made under Forest (Conservation) Act, 1980. Protected forest land proposed for diversion has been left untouched.

5	(a) As per GIS DSS analysis of proposed Compensatory Afforestation (CA) site is full of vegetation which is not suitable for plantation.	On Inspection, it was found that there are small patches present in the forest land proposed for Compensatory Afforestation where plantation will be made. Since there is no norms for better protection of 100 trees and better availability of irrigation for plantation of plants seperately. If separate boring is done which is as per Schedule of Rates Aligarh it will cost a huge amount of 26250/- per boring which is also not feasible. It is also not feasible to appoint a seperate watcher for protection of just 100 trees. Hence, the plantations in small vacant patches.
	(b) Site suitability shall be rechecked and suitability certificate shall be based on DFO's field visit.	Site suitability has been relooked as found to be correct as per above reason.
6	NPV calculation shall be based on correct area.	There is no correction in the proposed forest area as already shown under Objection no. 4 compliance, Hence NPV calculation has been left untouched.
7	Site suitability certificate for proposed CA and part V have not been uploaded.	Site suitability certificate for proposed CA and part V have been uploaded in Part II.
