The Point wise compliance with respect to the Additional information /clarification sought by Forest Advisory Committee

- i. The State Govt, shall provide the detail of all such cases where the User Agency (OPTCL) has violated the provisions of the Adhiniyam. The State Govt, shall also report the action taken under Section 3A/3B of the Adhiniyam in such cases.
 - The User Agency i.e., (OPTCL) has constructed a total of 62 nos. of Towers in forest land over an area of 0.42 ha across both Notified Forest Blocks and Revenue forest land under this forest division. This construction pertains to the transmission line project i.e., Diversion of 136.966 ha (94.013 ha in Balliguda Forest Division + 42.953 ha in Kalahandi North Forest Division) of Forest land for construction of 220/132/33 KV/DC Transmission Line from existing 220/132/33 KV Grid Sub-station at Sirtiguda of Kandhamal District. In view of the violation under the provisions of the Adiniyam in Notified forest blocks Two offence cases have been booked vide OR case No. 59 of 2023-24 of Balliguda Range and OR case No. 35 of 2023-24 of Tumudibandha Range against SDO, (Construction) OPTCL, Balligida Sub-Division and Project Manager, M/s Flowmore Ltd.
 - Further, encroachment cases have been duly booked by Tahasildar, K.Nuagaon, Balliguda and Tumudibandha against un-authorized construction of electric towers by OPTCL on Revenue forest land under K.Nuagaon, Balliguda and Tumudibandha Tahasil which was communicated by Collector, Kandhamal vide his letter No178 dated 12.01.2024 to undersigned.
 - The Action Taken Report on violation made by the User Agency has already been submitted to your good office vide this office memo No.2909 dated 16.05.2024.
- ii. The separate KML file for the transmission line indicating the proposed forest land is not available on the portal. The same shall be uploaded.
 - The KML file of the Transmission line of the Forest land which was submitted by the User Agency vide their office letter No. 274 dated 16.06.2025 is enclosed herewith for your kind reference.
- iii. In view of the presence of wildlife, particularly elephants, in the proposed project area, the Sensitive locations along the project route that require wildlife mitigation measures may be identified and a mitigation plan be formulated with the approval of the Chief Wildlife Warden.
 - The Site Specific Wildlife Conservation Plan for the project has been prepared and the same is being forwarded to the DFO, Kalahandi North Forest Division for obtaining the signature of all concerned and further approval at appropriate level for taking necessary steps at this end.
- iv. In case of violation, the state has only provided the area involved in the construction of towers, whereas the area involved the stringing of the wires has not been calculated. The needful shall be done and the detail of the exact area involved in violation shall be accordingly intimated.
 - This is pertinent to mention here that, as per field verification, it is found that, only towers were constructed by the User Agency in Notified Forest Blocks as well as Revenue Forest land and stringing of electric cables has not been erected yet. The details of tower constructed are depicted hereunder for your reference.
