
In reference to the subject cited above the point wise reply is given as under:-

1. The correction in part-II of form regarding CA area has been made.
2. As per para 2.5 (Special provisions for CA for certain categories of projects (page no. 47 of the Handbook), CA shall be maintained at the cost of the user agency on degraded forest land twice in extent of the forest area diverted. As per the provisions laid down in the Handbook Clause (g) of para 2.5, the compensatory afforestation proposal on degraded forest land shall be twice in extent of forest land involved has been prepared and uploaded on the parivesh portal. Moreover the alternate land certificate provided for afforestation by the user agency is 143 kanals which comes at 7.15 Ha which is half of the land proposed for diversion by the user agency.

2.5 Special provisions for CA for certain categories of projects:

g. Construction of link roads, small water works, minor irrigation works, school building, dispensaries, hospital, tiny rural industrial sheds of the Government or any other similar work excluding mining and encroachment cases, which directly benefit the people of the area in hill districts and in other districts having forest area exceeding 50% of the total geographical area, provided diversion of forest area does not exceed 20 hectares.
