Sir,

Kindly refer to your office letter No. 8B/HP/09/59/2018/FC/1119 dated 31.08.2018 on the subject cited proposal.

2. The point wise reply to the observations raised vide your above referred letter is submitted as under:-

1. The shape of the Forest land proposed to be diverted has already been uploaded as linear project in Part-1 A (vi) and C(ii). Whereas the category of the project has been mentioned 'others' because in the category list of projects, there is no option for Ropeway Project so it has to be mentioned in category as others.
2. Administrative approval of the project is uploaded and hard copy of the same is enclosed.
3. Scientific names of trees ^{have been} are uploaded online.
4. CA scheme of 8 ha. has been uploaded and hard copy enclosed. Digital Map, SoI Toposheet and land suitability certificate is uploaded and hard copies of the same alongwith soft copy of KML file is enclosed. As regard planting of 15900 plants, this has been proposed over 18 ha. in compliance of NGT orders dated 31.08.2017, copy of which has been uploaded and hard copy is enclosed.
5. The revised NPV bill is enclosed.
6. Working Plan prescription is uploaded now.
7. The muck generated has to be utilized within the same tower/ station, by construction the same, partly in cutting and partly in filling. So, no surplus muck will be available for dumping at other dumping site. The same has been shown in the plan already submitted with the proposal.
8. Necessary correction has been done now.
9. The detail of trees to be cut & to be retained has been uploaded online.
