Jaipur August 5, 1978

No. F. 3(16)Rev. dt/8/76. In exercise of the powers conferred by section 20 of the Rajasthan Forest Act (Rajasthan) Act No. XIII of 1953), and all other powers enabling him in this behalf, the Governor of Rajasthan hereby daclares the strips of lands whether under tree growth or not on either side of the metalled roads under control of PWD, transferred to the Forest Department for management as per schedule appended herewith to be protected forests and the provisions fo Chapter IV of the said Act and the rules made thereunder to be applicable to them.

In further pursuance of the pursuance of the powers conferred by Section 30 thereof, the Governor of Rajasthan further declares that the trees, shrubs, grass and other vegetation growing on the said strips of protected forest are reserved with effect from the date of publication of this notification in the Gazette and prohibits from the afforesaid date, the cutting, lopping, pollarding, uprooting setting fire or causing damage to the vegetation, removal of any forest produce in the said forests and breaking up or clearing for cultivation or for buildings, for grazing of cattle or for any other purpose, of any land in the said forest.
