

SITE INSPECTION REPORT OF THE DFO

Date of Inspection- 04.08.2022

The proposal includes part of Lakhisarai District on NH-333A Lakhisarai-Shekhpora-Sikandra-Jamui Road. The Proposal road is in total length of 5.40 KM. and 7.645 Ha. of road side P.F. is to be diverted in Lakhisarai District which is under the jurisdiction of Munger Forest Division, Munger. No unique/endangered species of flora or fauna was noticed in the area, neither there was any archeological/heritage site/defense settlement on the road side. For widening purpose the requirement of land is minimum.
