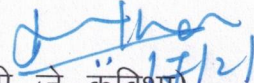

Sr. No.	EDS Raised by MoEF&CC	Reply
1.	The site details and erosion vulnerability statement in the proposal need to be corrected to reflect ground reality and that suitable soil conservation and mitigation measures must be incorporated.	As per the Proposal submitted by the User Agency, water shall be conveyed from the Chambal River bank to the proposed Pump House-1 by gravity through an open channel which is protected by grouting and stone gabions. The proposed Pump House-1 shall lift the water through underground pipelines and convey it to the proposed Pump House-2. The proposed Pump House-2 shall further lift the water through an underground pipeline and discharge the lifted water into the natural streams of Parbati and Ramsagar Dam. It is mentioned in the online parivesh portal proposal part-II Point number 6 soil is not vulnerable for erosion. The undersigned inspected the project site along with the representatives of the User Agency on 16.01.2025. During the site inspection, it was observed that a ravine exists between the Chambal River bank and the alignment of the proposed Pump House-1 and Pump House-2, which may be vulnerable to soil erosion. However, the remaining project area is predominantly rocky in nature, and no significant soil erosion is anticipated in these stretches. To address the erosion-prone ravine stretch, the User Agency has submitted an undertaking that, after laying of the pipeline, the soil shall be properly backfilled and compacted, and indigenous grasses shall be planted on the levelled soil to bind the soil, prevent erosion, and provide adequate stability to the trench. Although the natural streams are not prone to soil

		erosion, small loose stone check dams shall be constructed as a precautionary measure to arrest surface runoff and control soil erosion in the natural streams of Parbati and Ramsagar Dam, at the project cost. In this regard, separate undertakings duly signed by the User Agency are enclosed (Annexure-1) in compliance with the EDS for kind consideration.
2.	The inconsistencies in the CA cost, tree enumeration, and segment area data, must be reconciled and corrected in the proposal.	Initially, the forest diversion proposal was submitted for an area of 14.8859 ha, and accordingly, an equivalent extent of non-forest land was allotted and mutated in favour of the Forest Department. Subsequently, due to changes in the project alignment, the forest land proposed for diversion has been reduced from 14.8859 ha to 9.5611 ha. Accordingly, this office had prepared the Compensatory Afforestation (CA) Scheme for an area of 14.8859 ha, based on the initially proposed diversion area. The segment-wise revised area calculation sheet, reflecting the updated forest diversion area, has already been uploaded in the proposal (Anexure-2). The tree count information is as per the updated forest diversion area of 9.5611 ha, which was also uploaded in the proposal (Anexure-3).
3.	Recommendation of the PSC to be submitted. This issues with the approval of the Competent Authority.	The Project Screening Committee (PSC) recommendation for the referenced proposal has been received and attaches as Annexure-4.

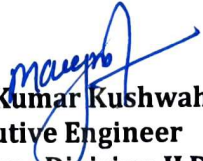

The proposal was examined in 52nd and 54th PSC meeting held on 4.8.25 & 8.9.25 respectively. After due deliberation in 54th meeting PSC recommended it for acceptance. Accordingly, the proposal was forwarded to the Deputy Conservator of Forests (DCF), Karauli, for completion of Part-II and for taking further necessary action.

Current deliberation details

DCF Karauli has returned the proposal after raising following observations:

1. The boundaries of the applied forest area are marked as per the department's KML file; however, these boundaries do not match with ground references/points and those marked

- on the respective SoI toposheet. Therefore, it is desirable that the proposal be submitted according to the forest boundaries marked on the SoI toposheet and the khasra map
2. The User Agency (UA) is required to submit the SoI toposheet, DGPS map, and superimposed khasra maps.
 3. The UA has submitted a map showing existing roads/paths; however, as per Google imagery, no such roads/paths appear to exist in the proposed forest area. Hence, to carry out the survey activities, the UA should provide complete details of existing roads/paths along with details of all machinery and equipment to be used for survey and exploration works.
 4. The submitted document titled “*Trench Method and Volume Excavation*” is not certified by the competent authority of the proponent.
 5. Similarly, the document titled “*Methodology of Trenching*” is also not certified.
 6. As per the report submitted by the Range Forest Officer, Hindaun, vide his office letter No. 805 dated 17.10.2025, trees will be felled at the proposed trench locations. Therefore, all trench locations must be clearly marked in the field in the presence of forest officials.

PSC Decision

During the meeting, the DCF apprised the PSC that tree counting has been completed. In this regard, the User Agency (UA) was advised to avoid tree felling and to submit an undertaking accordingly. Further, the PSC directed the UA to upload the certified documents as pointed out by the DCF.

After due deliberation and discussion with the DCF, Karauli, and the representative of the proponent, it was decided to return the proposal to the User Agency (UA) so that the documents/information desired by the DCF, Karauli, can be provided by the UA. Once these observations are addressed and complied with, the matter will be examined in the next PSC meeting.
