SITE INSPECTION REPORT NOT BELOW THE RANK OF DCF
(For forest land to be diverted under Forest Conservation Act, 1980)

A proposal has been received by this office from PWD, Gauchar for diversion of **2.23 Ha.** of Forest land under Forest Conservation Act, 1980 for non-forestry purpose. The project envisages transfer of Forest land of Van Panchayat forest for Guachar- sidoli- Dhanpur m/r extension.
I have carried out the site inspection of the land required on date 22-06-2015

Upon inspection of the site, the following has come to light:

1. It is found that the land required by the user agency is a RF/PF//Unclassed/Protected Forest. The break-up of the land is as under:
