I Submit that the details as called in the Principal Chief Conservator of Forests Chennai reference 7th cited is furnished as follows:-

As per the provisions of chapter 2.5 under Part-B of Forest Conservation Act, 1980 guidelines, Compensatory afforestation shall be raised and maintained at the cost of user agency on degraded forest land twice the extent of forest area diverted for laying of telephone / optical fiber cable.

An extent of 0.193 Hectares of Forest land was proposed for this project. Total degraded forest land identified for compensatory afforestation for this project is an area of 1.00 hectares. An effective area of 0.40 hectares will be selected in the Suranganar Reserve Fore of Cumbum west Range for Compensatory afforestation.
