

In this context, it is intimated that the reply of point wise observation raised vide above referred communication is given as under:-

Sr. No.	Observation	Reply
1.	The Justification submitted in response to Point No. 1 is not in consonance with the observations of the GoI. The detail of the explored alternatives has not been furnished adequately. The justification needs to be revised and submitted in greater detail, including particulars such as enumeration, area involved and other relevant specifics as specifically sought by GoI.	In this regard, it is intimated that as per the User Agency the alternate-I has been selected for the proposed project as most suitable & feasible as per requirement of the project and alternate-II & III are rejected as not suitable and feasible as per requirement of educational institution. The revised Justification for alternate examined including particulars such as enumeration, area involved has been uploaded against additional information detail in online Part-I at serial No.31 has been uploaded by User Agency.
2.	In response to observations at Point No. 5, 6, 7 and 9, it has been stated that the requisite information /documents have been uploaded on the portal. However, the details of the uploaded documents such as Sr. No., Column No. etc. have not been mentioned. The same may be clearly indicated.	In response to EDS at Sr. No. 5 of GoI, the Eco Sensitive Zone Certificate clearly mentioning the distance of the proposed site from WLS has been uploaded against the additional information detail at Sr. No. 15 in online Part-I by the User Agency. In response to EDS at Sr. No. 6 of GoI, the revised joint inspection report has been uploaded against additional information

3.	In response to Point No. 10, the Layout Plan uploaded on the portal is not found to be signed by the concerned DFO as specifically required by the GoI.	The Layout Plan duly authenticated by undersigned has been uploaded against additional information detail in online Part-I at serial No. 32 by the User Agency.
4.	The purpose wise and component wise detail of Khasra number as sought by GoI at Point No. 11 have not been found uploaded on the portal. The detail of the relevant documents including Sr. No., Column No. may be clearly mentioned in the forwarding memo.	The purpose wise and component wise detail of Khasra number as sought by GoI at Point No. 11 has been uploaded against additional information detail in online Part-I by User Agency at No. 33.
5.	In response to Point No. 12 & 14 of GoI, it has been stated that the needful has been done. However, the number of trees continues to be reflected as 392. Necessary revision/correction in the relevant online columns is required, along with submission of revised tree enumeration.	In the reply of Point No. 12. there are 341 Nos. of trees are coming in the above proposed site & out of which 290 Nos. of trees are to be felled and the revised enumeration list of trees has also been uploaded against the additional documents in the Part-II column. Further, in response to EDS at Point No. 14 of GoI, the Certificate of non-availability of NFL on Schedule-III format has been uploaded at Sr. No. 21 against additional information detail in online Part-I by the User Agency.
