1. Justification on the area to be diverted by including details of area that will be inviolate vis-a-vis diverted area.

Village Nivale Tal. Shahuwadi Dist. Kolhapur is rehabilitated in two different villages of Kolhapur district namely village Galgale Tal. Kagal Dist. Kolhapur and village Wathar Tal. Hatkanangale dist.Kolhapur. At village Galgale there was problem of original land holder and Govt. regarding land aquisition. So he filled Writ Petition in Hon. High Court Mumbai. Hon. High Court Mumbai given its decision against Govt. Order of aquisition process. So issue was become serious after longtime of rehabilitation process. So people who rehabilitated in village Galgale demanded land in same tahsil. So present proposal is submitted for clearance under Forest (Conservation) Act, 1980. There is no alternative land available for distribution to project affected persons.

Village Kagal Rehabilitation Proposal

Govt. of Maharashtra for the reasons of ecological, faunal and floral significance has notified an area of 308.97 sq.km., as Chandoli wildlife sanctuary vide notification No.WLP- 1085/ C.R-588/ (II)/F-5 dated 16-09-1985, under the provisions of Wildlife protection act.1972, for the purpose of protecting, propagating and developing the wildlife therein and its environment. Govt. of Maharashtra vide notification No. WLP, 1999/C.R.-117/F-1 dated 14-05-2004 declared Chandoli Sanctuary as Chandoli National Park by adding Amboli village's geographical area to the National Park.

The inquiry under section 19 to 25 of wildlife protection act 1972 for the Chandoli wildlife sanctuary was conducted by SDO.walwa for Shirala Tahasil, SDO. karveer for Shahuwadi Tahasil, SDO.karad for Patan Tahasil and SDO. Chiplun for Sangmeshwar Tahasil. All these inquiry officers have completed inquiry in respect of Rights and privileges of the people and they have submitted their inquiry report to district collector.

Govt. of Maharashtra for the reasons of ecological, faunal and floral significance has notified 32 villages of area of 308.97 sq.km., as Chandoli wildlife sanctuary vide notification No.WLP-1085/C.R.-588/(II)/F-5 dated 16-09-1985.

The inquiry of the area has been completed by S.D.O Walwa (for 19 villages), S.D.O. Karveer (for 9 villages), S.D.O. Karad (for 3 villages) and by S.D.O. Chiplun (for 1 villages) in Sangali, Kolhapur , Satara and Ratnagiri District.

Out of the 32 villages in the notified area of P.A the breakup is in tabular form as under.

(In above tabular form 5 villages of Sangali District and 3 villages of Kolhapur District already shifted outside P.A. due to Wana Project only some land in above 8 villages will be acquired.)

6 villages as Nivale, Tanali, Chandel, Tambave paiki Kulyachiwadi, Dhakale, and Sonarli Paiki Dhanagarwada Villages in Shahuwadi Tahasil of Kolhapur District and some families/Khatedar of Gothane village in Sangmeshwar tahasil of Ratnagiri District are relocated in the villages of Shirol, Hatkangale and Panhala tahasil of Kolhapur District. Details the breakup of Area and Khatedar as villages wise is mentioned in tabular form is as under.

In above tabular form the total land to be allotted in 757.77 ha. area needed for rehabilitation for person of Chandoli Wildlife Sanctuary.

So, Disforestation of 215.42 ha. Forest land for the rehabilitation of 7 villages from Chandoli Wildlife Sanctuary, the proposal of Forest (Conservation) Act 1980, has been submitted to Central Govt. for Sanctioned. In present Government of India has accorded in-principal approval for this 215.42 ha. Proposal.

After disforestation of 215.42 ha. Proposal, the remaining area for rehabilitation of Chandoli Wildlife Sanctuary is 542.35 ha. So at present the 162 families of Nivale village in Shahuwadi Taluka Dist.Kolhapur have been rehabilitated 89 families in Wathar taraf Wadgaon, Taluka Hatkanagale and 73 families at Village- Galgale Taluka- Kagal, Dist. Kolhapur.

For 73 khatedar of Village- Galgale Taluka- Kagal. Dist Kolhapur. The revenue department of Kolhapur had rehabilitated an approximate area of 16 hector for agriculture use. After Land acquisition process was completed by Revenue Department on private land, but the person whose land was land acquired was aggrieved in matter and filled Writ Petition no. 11259/2014 & 11616/2014 in Hon. High Court Mumbai.

Hon. High Court Mumbai given its decision against Govt. land acquisition process by mentioning that the land acquisition process made by Govt. of Maharashtra is not as per law provisions. As per judgment of Hon. High Court of Mumbai dated 16th February 2016, the land of Village Galgale Tal.Kagal has been given to the Concerned Original land owner.

So people of village Galgale have selected 63.091 ha area of forest land in Kagal, Tal-Kagal, Dist.Kolhapur for their rehabilitation for agricultural use. Hence, Kolhapur forest Division proposed proposal of Forest (Conservation), Act 1980. for these all 73 Khatedar of village Galgale who selected 63.091 ha forest land at Kagal, Tahsil Kagal dist. Kolhapur. The details of forest land requirement for rehabilitation is as under.

The concerned Project affected persons Selected the forest area for agriculture use in village Kagal, forest Gat Number 200,201,202,203,204,205 area is 62.83 ha. and 0.261 ha of Forest Gat no.181 forest area for Kaccha road .Total forest area required is 63.091 ha. has been demanded. in Village Kagal Taluka-kagal Dist.-Kolhapur. Also, in private Gat number 207, 214, 215 of 566m length x3m width = 0.1698 ha. for the road will be required for this proposal.

Hence, proposal has been submitted under the Forest (Conservation) Act, 1980 for disforestation.
