
In inviting a reference to GoI, MoEF & CC, IRO, Bhubaneswar letter cited above on the captioned subject, the DFO, Keonjhar Forest division has furnished a Compensatory Afforestation Scheme over an area of 4.02 ha of non-forest land identified in village Podadihi under Bansapal Tahasil of BJP Range of Keonjhar division.

The financial outlay of the said CA Scheme has been approved for **Rs 32,44,800/-** (Rupees thirty two lakhs forty four thousand and eight hundred) only by the PCCF (FD & Nodal Officer, FC Act) with provision to take up AR plantation @1000 plants/ha, chain link wire mesh fencing, AMC activities and watering by Diesel pumpset fitted with borewell etc as per approved one time cost norm.

In this context, one set of the CA Scheme alongwith the financial outlay is enclosed herewith for favour of kind information and necessary action.






