
With reference to the above cited memo No. on the correspondence subject, it is to inform that the proposal for diversion of 87.52 ha. of forest land including alternate road for construction of Hidsingh Irrigation Project under FC Act, 1980 by Executive Engineer, Cuttack Investigation Division, Jobra, Cuttack.

In view of the above, the user agency i.e. Superintending Engineer, Angul Investigation Division, Angul has submitted the point wise compliance report vide his letter No. under reference (3) as per observation made by the Principal Chief Conservator of Forests, Forest Division & Nodal Officer, FC, Act. O/o the PCCF, HoFF, Odisha, Bhubaneswar vide his memo No. under reference (2). The details are furnished below.

Observations made by the PCCF, Nodal, FC, Act. , Odisha, BBSR		
1	Objection	In observation point No. 03, field verification report of the DFO, Angul Forest Division has not been furnished.
	Compliance	<p>In compliance to this observation, the field verification of Divisional Forest Officer, Angul Forest, Division is enclosed as Annexure-I.</p> <p>The identification non forest land having vegetative growth has been verified.</p> <p>It is observed that Mango orchard are present in tenant land in an area of 0.27 acre and clear vegetation in 0.60 acre.</p> <p>Tenant can be fairly compensated by UA for tree growth after valuation of Timber and Fruit trees.</p>
2	Objection	<p>In observation point No. 04, it was requested to revise the CA scheme over 94.216 ha. Non-forest land as 53 ha. (out of purposed non-forest land 94.216 ha.) was found to be VDF & MDF through DSS analysis. Now, the CA scheme has been revised taking into account ANR with 600 plants per ha over 40.216 ha. & ANR without Gap plantation over 54 ha.</p> <p>To accommodate the balance seedling, 116.743 ha degraded forest land (80.002 ha. in Bega RF & 36.741 ha. in Lahada RF) in Dhenkanal</p>

		<p>Forest Division has been identified. The Addl. CA scheme has been prepared taking with ANR with 600 plants per ha.</p> <p>As this proposal is a new proposal & the CA scheme have not been approved by the Nodal Officer earlier, the CA scheme should be prepared being the “one time cost norm for CA ”</p> <p>This project involves forest area 87.52 ha. total numbers of seedling required to be planted will be 87.520 (87.52 ha x 1000 Nos.). The CA scheme over 94.216 ha. and Addl. CA scheme over the degraded forest land have to be revised accordingly to accommodate the requisite number of seedling.</p> <p>As per instant guidelines, DGPS map of all the CA land (both non-forest land & degraded forest land) authenticated by ORSAC & duly signed by all concerned is to be furnished along with the CA scheme.</p>
	Compliance	<p>In compliance to this observation, the Divisional Forest Officer, Deogarh Forest Division has intimated that the revised scheme basing on the onetime cost norm for compensatory Afforestation of Hising Irrigation Project against 94.216 Ha. Non-forest Government Land. The CA scheme forward to the Principal Chief Conservator of Forests, Nodal O/o the Principal Chief Conservator of Forest, Odisha, Bhubaneswar vide memo No.3055 dt. 21.06.2023 under intimation to the undersigned vide memo No. 3057 dt. 21.06.2023.</p> <p>To accommodate balance seedlings 140.744 ha of degraded forest land (Bega RF 80.002 Ha + Lahanda RF 36.741 Ha + Kapilasa RF 24.001 Ha) has been identified in Sadangi Range of Dhenkanal Forest Division. Accordingly, CA schemes has been prepared by the Divisional Forest Officer, Dhenkanal, Division ANR plantation 500 no. of seedlings per ha as per “Onetime Cost Norm” over an area of 140.744 Ha (70372 no. of seedlings) to be planted and the revise CA schemes has submitted to this office vide memo No. 6589 dt. 08.08.2023 is enclosed as <i>Annexure-II</i>.</p>
3	Objection	<p>In observation point No. 9, it was requested to prepare the CATP as per guidelines of MoEF and CC, Govt. of India envisaged at Chapter-9 of Hand Book-2019. In compliance to this, the undertaking submitted by the User Agency to take up the CATP after obtaining Stage-I clearance which is unacceptable. The approved CATP scheme has to be enclosed along with the diversion proposal.</p>
	Compliance	<p>In compliance to this observation, the User Agency i.e Superintending Engineer, Angul Investigation Division, Angul has submitted the CATP scheme to the undersigned. It has been submitted to the Regional Chief Conservator of Forests, Angul, Circle, Angul for consideration and taking necessary action for approval from competent authority vide this office memo No. 6642 dt. 18.10.2023 is enclosed as <i>Annexure-III</i>.</p>

In view of the above, the compliance report received from the User Agency in 4(four) sets along with Pen-drive are submitted herewith for kind information and necessary action. **Encl: - As above.**


