During the Joint Inspection along with concerned forest staff and Project Authority on Dt. 09/06/2021, it is noticed that the violation has been done which is initiated in the year 2018.

Executive Engineer (Civil), S & I Kalyan under Indian Forest Act 1927 as per section 32, 33 and Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 section-2 vide PCR No. R.O.No.29/E & 30E/2020-21 Dt. 15/03/2021.

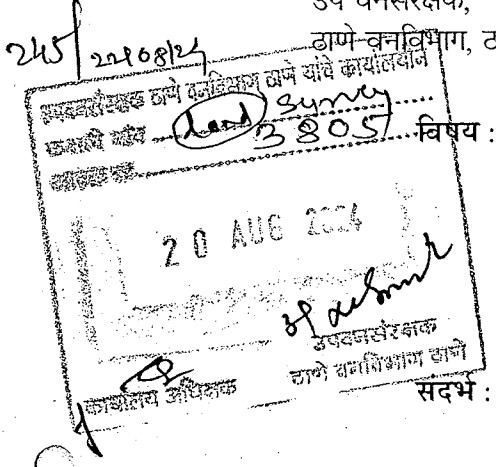





Annexure -1 C -Brief information of the case

- 1) On date 15. 03. 2021, along with Round staff while inspecting, towards the East area in the Protected Forest Sec. No. 211, in Mauje - Madoshi village It was found that a foundation of a tower was erected by encroaching on the forest department's land, the transmission line is 220 KV Padgha Wada, the Tower no. is 38. A case against Mr. Milind D. We the Pancha after visiting the place and inspecting it, write that the accused - Mr. Milind D. Jadhav, Additional Executive Engineer (Civ.) S. V. N. Kalyan, has been questioned in front of us. We got to know that the 220-KV M/ C Lilo, Padgha Kolshet Wada- Illegible text??? Transmission Line Work is under construction, under Mahapareshan Department of Kalyan. Mr. Milind Jadhav is confessing us before the panel that, the said line is under construction on the land of Mr. Laxman Janu Pilane, Mauje - Kunda, Tal. Bhiwandi, he has checked that the land belongs to the above-mentioned person according to the 7/12 extract document. The Forest Conservator confesses that the said area 19, has been given to the local people by the Forest department. The said area is - Protected Forest Sec. No. 54 is not mentioned in the 7/12 extract document.

The rice crop is under cultivation in the said area. There is no barren land in the mentioned area. The person is farming in that area for a long time. After inspecting the said area, we saw that towards the Eastern area of the above said land belongs to Mr. Arjun Lakshman Pisane. The area belonging to the above-mentioned person is under

rice cultivation. The land towards the West and the South belongs to Mr. Ladku Ganu Dukale. The land towards the North of the above-mentioned person belongs to Mr. Arjun Laxman Pilane. There is no existing tower or markings in the above-mentioned parts by the Forest Department.

Forest Conservator- Dighashi, took us to the place where the tower was built and we performed GPS reading of the construction. The details are as follows -

Sir, as per your letter, Outward. No. Room-1/Land / Forest/716 Year 2020-21, Padgha 421101 On inquiry dated 23. 2. 2011, I, Milind D. Jadhav, Additional Executive Engineer (S&I) Maharashtra Vidyut Parishan Company Ltd., is providing my statement as follows-

The transmission line of Lilo, 220 KV Padgha -Wada Kolshet Wada and the transmission line 400 KV connecting to Kudus Sub-division has been sanctioned as per M. D. R. 112/26. Thereafter the survey work of the said power lines was handed over to M/s. Vinayak Consultancy by the said Department. According to that, the said contractor completed the survey work in 2017. While surveying, it is observed that this transmission line starts at Mauje Dighashi and goes through the villages of Dighasi, Kunda, Chinchawali and Eksal. The said contractor was clearly instructed by the Electricity department to use the least area or if possible, to not use any area belonging to the Forest Department. As per the letter mentioned above, Tower no. 38 has been constructed in Protected Forest Survey no. 211 at Mauje Dighashi and the Tower no. 37 is constructed in the Protected Forest Survey no. 54 at Mauje Kunda.

Accordingly, you are hereby informed that, during the survey, it was found that the Land survey no. 35/ 4 under the Protected Forest land survey no. 211, Mauje - Dighashi is owned by Occupant 1 Mr. Mahadev Dagdu Jadhav. There is no registration of the Forest Department on this 7/12 extract document. Therefore, it was concluded that the said area is not a forest land. Due to this, by mistake the above-mentioned contractor did not inform the Department that the land belongs to the Forest Department. Similarly, during the survey, according to the inspection, it is found out that Tower No. 37 constructed in Forest Land Survey no. 54, comes under the Revenue Department according to their 7/12 extract document.

On inspection of the said area, there is no sign of belonging to the Forest Department. The said area is under cultivation. Therefore, it is not indicated that said land comes under the Forest Department.
