Sir.

As desired by Government of India vide letter dated 10/02/2017, Addl. Principal Chief Conservator of Forest, Mangrove Cell, Mumbai has submitted the copies of queries compliance. A copy of the same is enclosed herewith for your information and further necessary action.

The User Agency has explored alternatives and stated that the option 1 is located on E. Block Bandra Kurla Complex (BKC) beneath the fully developed area of Government & corporate building infrastructure such as Reserve Bank of India, housing societies, Corporate Parks, MMTC Ltd. etc. In this option there is no open space. Road available for the construction of station. However, executing this option by demolition of fully developed & functional infrastructure, is not possible as per the studies the alignment shown in Map 1 and map 2 are passing through already developed area (Commercial and Residential area) the option 2 is located in E block BKC in the mangroves area near to Mithi River. The construction of station at this location will result in cutting large number of mangroves thereby causing damage to ecology. In this option, the advantage of utilizing road area is also not possible. In view of above a present KBC station is in E Block BKC distributed towards northern and southern end

of income tax junction providing access to both commercial and residential area at this location, the road area is fully utilized for construction purpose there by reducing the area of mangroves to be cleared. The Divisional Forest Officer (Mangrove), Mumbai has also certified that no alternative alignment is possible and the forest land required is the barest minimum. On this ground. PCCF Office has recommended the proposal and submitted to Government of India for approval.

It is therefore requested that the required information may please be taken into consideration & the proposal under Forest (Conservation) Act, 1980 may be approved as early as possible.
