





Case Title: Diversion of 0.486 hectare of forest land in favour of HPPWD for the construction of link road from Balhi to Chuwari Km 0/0 to 1/00 within the jurisdiction of Bilaspur Forest Division

~Note on Violation~

On visiting the forest land proposed for construction of link road from Balhi to Chuwari, the undersigned found that a road having approximately 1000 mtrs length and 3 mtrs. wide has already been constructed on the spot without the approval of Competent Authority, which is clear cut violation of provisions of FCA,1980. Keeping in view the extent of violation, damage approximately Rs. 7,50,000 /- on a/c of breaking of land /digging of soil and Rs. 1,50,000 /- on a/c of compensation thereof total amounting to Rs. **9,00,000 /-** has been occurred. From the perusal of record pertaining to case, enquiry from the local people on spot, it reveals that existing road was constructed by the local people about 35-36 years ago. As this road has been constructed a long time ago, it is not possible to fix the responsibility of officer/officials for commission/omission of any action leading to the violation of FCA, 1980.
