6	The reply of points no 10 EDS regarding presence of MDF over 3.00ha area identified for CA has not found satisfactory Nodal office has not given any comment on the issue . Moreover nothing have been mentioned about t no of trees and the density of vegetation in the area identified for CA in the certificated issued by DFO. 7	The site wise legal status of land including dimension identified for disposal of muck has not been given in the muck disposal plan further, nothing has been mentioned about the query made in point o 12 of EDS 12-06-2016.	Now all the muck disposal will be carried out in non forest land (nap land). the previously shown location which are situated in forest area are now removed and whole of the muck is disposal in

		nap land therefore, no need to revise the proposal. Certificate of the same is uploaded and attached at designated place.
