Connectivity road to L.Malayur village is 2 km distance to nearby villages. Out of this 0/0 - 2/2 to 2.20 km area is belongs to Forest Department.


Total population of this village is 1036 (425 voters).

**ORDERS:**

In the reference 1<sup>st</sup> cited, the District Forest Officer, Dindigul has requested to provide twice revenue land for acquiring 1.68.0 Hectores of forest land in perumalai reserve forest for compensation on land owned by the Forest Department for formation of Road to L.Malayur. In this regard Tahsildars Dindigul East and Natham were instructed to submit an proposal for suitable Government Prompoke land to elegeble for compensation in near by vicinity of mudimalai / kodangi reserve forest lands near the ayyalur interface forest Division in the Juristiction of Dindigul and Natham taluk.

Protected of the forest land, which was eligible land for issuing the Compensatory land and the classification of Govrenment promboke lands and recommended by Tahsildars Dindigul East and Natham. In this connection, Dindigul District Natham taluk, lingavadi village for foming the road to the L.Malaiyur of the said land belongs to the forest dept., of the permalai reserve forest of 1.68.0 hectares is as compensatory Afforestation land which was located natham taluk,

senturai village, survey No.1154 of the total extent 17-41-50 Hectares of the govt. porampoke unsettlement dry land mentioned in revenue records as filed "Rock" which was two times of the compensatory land that is 1.68.00 hectares land taken which was received as compensation land issued recommended for issuing the compensation land of 3.36.00 hectares. In the references 4th and 5th Letters cited of Thasildar Natham and District Revenue Officer, Dindigul. According the District Revenue Officer's field inspection report has been received for consideration the particular compensation land vide reference 6<sup>th</sup> cited.

### Trees, Buildings and standard Systems :

The Proposed site for the Forest Department is Natham Taluk, about 2.0 km from Kudagipatti on the left side of the Road to Karuthanayakkanpatti, along the Mudimalai Reserve Forest and at the foot of the Mudimalai. This includes small Trees and Bushes for firewood Use. There are no Precious Trees. The Water coming from the foothills is field number like a stream. In the South of field number 1145 it goes about 20 feet from west to East and goes North again. Also a small hill to the North of the Publishing field is about 170 meter lenth and about 80 meter wide in the South. It is also stated in the reports of Natham Thasildar and Dindigul Revenue Divisional Officer and field inspection report of the Dindigul District Revenue Officer that there are No Ancient monuments, Public Temples, Mosques and Places of worship in the Publishing field and None of the high and low voltage Power lines across this area, and it is an ideal area to provide compensation to the Forest Department.

### Objection details :

Dindigul District, Natham Taluk, Sendurai Village survey No.1154 total area 17.41.50 Hectares of Government Classified as Non-Settlement fallow Land. No Objection were received from the Public or other persons Regarding the Publication of the A-1Notice in Sendurai Village from 18.07.2019 to 01.08.2019. There are no Encroachments on the land and the land is not recorded in the Prohibition / Objection Book.

### Subdivision :

Dindigul District, Natham Taluk, Sendurai Village field No.1154. It is proposed to Provide 03.36.00 Hectares of land as Compensation to the Forest Department out of a total area of 17.41.50 Hectares. subdivision details as follows

Determining the value of land :

Dindigul District, Natham Taluk, Sendurai Village survey No.1154 total area 17.41.50 Hectares to be provided as Compensation land adjacent survey number to determine land value of land survey No.1145. are selected as the exam in filed. According to the Government guideline Register of 1145, Rs.76,500/- has been fixed. Accordingly the value of 03.36.00 Hectares of land proposed to be provided as compensation land is Rs.2,57,040/-

Dindigul District, Natham Taluk, Sendurai Village survey No.1154 total area 17.41.50 Hectares state nature and Dindigul Revenue Divisional Officer has recommended that 03.36.00 Hectares of land in the reference cell as non-settlement barren land can be given to the forest Department as compensation without any land value and other charges.

District Revenue Officer, Dindigul has surveyed the field on 05.11.2019 and proposed to provide natham Taluk Sendurai Village survey No.1145 stateless – settlement Barren land with small trees and bules for firewood use and therefore suitable land natham Taluk, Sendurai village survey No.1145, total area of 17.41.50 Hectare 03.36.00 Hectares of land is to be provided as compensation to the forest Department as per sub division documents as per Revenue level Order No.23A,



Central Forest Protection Act, 1980, Section 3.2(i) and G.O.No.503, Revenue (Nee.Moo.4-1) Department has recommended that land can be Transferred without any Valuation and other Charges.

As on 21.09.1999.G.O.No.503 Department of Revenue (Nee.Moo.4-1) dt., 21.09.1999. In Consultation with the concerned Department at the District level to provide the minimum land required for the needs of the Concerned Department without any Valuation and other charges for a general, non-Commercial use of lands other than restricted lands such as water Stagnation has been Ordered.

In addition, under section 3.2(i) of the Central Forest Protection Act, 1980, It has been Proposed to provide Double the Amount of land as Compensation for the Acquisition of land under the control of the Forest Department for other purposes and to increase the cost of Plantation Production to increase the Green Cover on those lands.

Therefore, at the request of the defendants and on the recommendation of the Thasildhar of Natham and the Revenue Divisional Officer of Dindigul, Natham Taluk, Lingawadi Village, 01.68.00 Hectares land in the perumalai reserve forest owned by the Forest Department in order to formation a Road to L.Malaiyur. Dindigul District, Natham Taluk, Sendurai Village, survey No.1145 Total area 17.41.50 Hectares of Non- Settlement not created the Kist of the dry land 03.36.00 Hectares of land Revenue level Order No.23A and Section 3.2(i) of the Central Forest Protection Act, 1980 –Ordering the Provision of Compensation to the Forest Department without any Valuation or other Charges.

In Addition, the Block Development Officer, Natham is directed to take appropriate action to remit the cost for Plantation Production as determined by the Forest Department to increase the Green Cover on the land provided as Compensation.
