

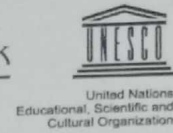



The point wise reply of the observation is as under:-

1.	In reply to point No.6 CF has intimated that the proposal for wild life clearance has been submitted online vide proposal No.FP/HP/VELEC/1502/2017 on 10-03-2021	The case is still under process.
	In reply to although the date has been mentioned in hard copy of Part-I but the date has now been mentioned 21-08-2021, whereas the DFO has mentioned 28-06-2021 in hard copy of Part-II and in Part-III , CCF has mentioned 1-7-2021. How the user agency can submit the part-1, after DFO/CCF. Necessary correction is required to be made in the date mentioned in hard copy of part-I.	User agency has replied that the proposal has been submitted on 13-07-2020 (copy enclosed), but the proposal folder received back for attending various observations. At observation No. (7) it was observed that "No date has been mentioned in hard copy of Part-I", after putting in the current date i.e. 21-08-2021 in the part-I, the ibid proposal folders were re-submitted on dated 23-08-2021(Copy attached). It is worth to mention here that the original proposal folders were submitted on 13-07-2020, it was a resubmission after attending the observations.
3.	In reply of point No.12, Needful has been done has been mentioned. But still there is difference in district profile mentioned in online part-II, the stipulation of CA '0' the progress 102.06 has been shown. In hard copy of part-II, the stipulation of CA 164.00 Hac. of forest land has been mentioned and against which the progress CA 102.06 has been shown. Necessary corrections are required to be made in district profile.	Necessary corrections have been made in district profile as per hard copy.
4.	In reply of point No.13, Needful has been done has been mentioned and PDF of part-II & III has been uploaded against additional information detail.
