Sub: Proposal for seeking prior approval of the Central Government under Section 2 (ii) of the Forest (Conservation) Act, 1980 in favour of M/s Tata Steel Ltd. for non-forestry use of 303.066 ha of forest land including 66.126 ha of non-forest land recorded as Forest as on 25.10.1980 involved in the mining lease area over 464.00 ha within Bamebari Iron & Manganese Mines in Keonjhar District, Odisha(Online Proposal No. FP/OR/MIN/20095/2016) –reg.

X-Sub: **Submission of compliance report of the observations.**

With reference to the aforementioned letters on the captioned subject, the point wise compliance report of the observations of the aforesaid proposal is depicted below:-

1. PDF attached in Part-I under Additional information column on PARIKESH portal at S. No. 49 to 58 are not accessible.

The user agency has stated vide his letter No. BIMM/L&L/20/2025 dated 10.01.2025 that, all required documents are uploaded in the additional information section of Parivesh portal. Further, it is to mention here that Sl No.49 to 58 are not available in Parivesh portal, and hence, no additional information is provided there as sought.

2. Component wise KML file of the proposed mining is not given.

The Component-wise KML file of the proposed mining has been uploaded in Parivesh portal & the said KML file is enclosed herewith in **CD format**.

3. Exact KML file of the 240.0 ha CA area is not given. More over KML file of the CA area and Addl. CA area for balance seedling has not been uploaded online.

The Additional Compensatory Afforestation land over 240.00 ha KML file has been uploaded in Parivesh portal & the said KML file is enclosed herewith in **CD format**.

4. The given KML file of the safety zone has been checked on DSS and it has been observed that the software calculated area of the safety zone (including green belt) KML file and the area given in the proposal has a difference of 11.171 ha. Complete KML file of the total forest land involved in the safety zone shall be uploaded on the portal.

The KML file of the safety zone including green belt has been uploaded in Parivesh portal & enclosed herewith in CD format.

5. Details of the notifications of RF and revenue/relevant records of the recorded forest (Revenue Forest/DLC Forest/Sabik Forest) involved in the proposal are not legible.

In the instant diversion proposal, the Reserve Forest land over 115.308 ha is involved in two RFs namely Thakurani RF & Sidhamtha RF. The notification of said two RFs, as available, are enclosed herewith as **Annexure-I**.

6. Copy of the notification of the land submitted on 30.06.2004 for declaring the 145.329 ha non-forest land as PF/RF is not given.

The proposal submitted on 30.06.2004 for declaring PF over 60.3 ha non-forest land in respect of village Rugudikasada under Banspal Tahasil over 19.640 ha & village Tiriba under Banspal Tahasil over 40.660 ha has been notified as PF. The copy of the said PF notifications is enclosed herewith as **Annexure-II**. The balance 85.029 ha is broken-up land prior to 25.10.1980. So CA land not required.

7. The DFO Keonjhar wrote to the District Magistrate to take legal action against Tata Steel Ltd for use of DLC and Khesra Forest land without approval under FC Act, 1980 involved in the mining lease on 17.11.2021. However, only a letter dated 14.02.2023 has been written to Tahsildar. The report on the violation of the FC Act, is not tenable. In this regard a detailed action taken report shall be submitted by the State against violation.

The Tahsildar, Barbil has intimated to the Additional District Magistrate, Keonjhar vide his letter No.4502 dated 22.10.2024 (**copy enclosed**) and copy endorsed to the Divisional Forest Officer, Keonjhar Division in the next memo of even date that due to use of forest land measuring of 27.495 Ac. (11.1268 ha) within mining lease of Bamebari Iron Ore Mines without prior approval from MoEF&CC, Govt. of India, New Delhi, Accordingly, 13 nos Encroachment Case has been initiated under OPLE Act, 1972 and back rent and penalty of Rs. 89,92,530/- (Rupees eighty-nine lakh ninety-two thousand five hundred thirty) only is imposed and demand notice sent to M/s Tata Steel Steel Ltd. with a direction to vacate the encroachment land within 30days. M/s Tata Steel Steel Ltd. has also deposited the above said amount vide M.R No.0394940 dated 22.10.2024 by Nazir, Tahasil Office, Barbil. The Money Receipt is enclosed herewith as **Annexure-III**.



Minutes of Joint Verification:

List of participation of the Forest-Revenue joint verification committee is given at Table 1.

Joint Verification of the boundary of **Sidhamatha RF** Forest Block was carried out during 24-04-2022 to 31-05-2022. Existing pillar position recorded through GPS were plotted and compared against geo-referenced cadastral maps of adjoining villages. The verified forest boundary map is enclosed at Plate-1. Findings of the verification w.r.t. revenue cadastral is given below:

As per the current WP Area mentioned at page 28 is 14754 Ac (5970.732 Ha.) enclosed as Appendix-II. 4. The management area mentioned as 5869.77 Ha. at page 492 of the current WP (2022-23 to 2031-32) enclosed in Appendix-III. 5. The FB Boundary verification are in conformity with the cadastral map of the adjoining village, HRSI, adjacent FB & Existing Pillar. 6.The JV boundary nearly matches with the management map. 7. The JV area Is found to be 6055.188 Ha. i.e, 1.415 % more /less than NFA. 8. The change of Area may be due to old survey technique and process of Area computation. Since the peripheral village have been settled prior to 1980.




