## SITE INSPECTION REPORT

A proposal has been received by this office from Deputy Manager, P.G.C.I.L., Ajmer for diversion (under FCA-1980) of **400 KV Ajmer (New)-Ajmer(RVPN) Power Transmission line for Power Grid Corporation of India Limited, Ajmer on Forest Land to be diverted 6.35 hectare** of forest land for non forestry purpose. The subject envisages the use of forest land for **400 KV Ajmer (New)-Ajmer(RVPN) Power Transmission line for Power Grid Corporation of India Limited, Ajmer on Forest Land to be diverted 6.35 hectare** as described below as per revised annexure submitted by user agency-
