SI No.	Compliance/ Condition
1	The name of the Forest Block is not mentioned in the ORSAC vetted DGPS map of the proposed forest land for diversion. It needs to be clearly mentioned in the map.
Compliance	The name of the forest block is now mentioned in the ORSAC vetted DGPS map of the proposed forest land. Now the map is submitted with diversion proposal.
2	The ORSAC vetted DGPS map of the CA land identified in 15 No. of patches (RF, PRF & DPF) over 1400 ha. has not been furnished in the DP.
Compliance	The ORSAC vetted DGPS map of the CA land identified in 15 No. of patches (RF, PRF & DPF) over 1400 ha. are now submitted in a separate folder with diversion proposal.
3	The Cost-Benefit Analysis needs to be rectified basing on the present NPV rate
Compliance	The revised Cost-Benefit Analysis basing on the present NPV rate is now submitted at page No.40, 41 and 42 in the diversion proposal.
4	The undertaking submitted by the UA to be countersigned by the DFO, Koraput Division.
Compliance	The undertakings submitted by the UA in the diversion proposal are countersigned by the DFO, Koraput Forest Division.

Hence, the said diversion proposal in 02 (two) sets is re-submitted herewith for favour of kind information and necessary action.
